The undersigned stresses in particular that, in accordance with the perception of consumers in the national territory in which the undersigned operates, any website with the gTLD .LOTTO is likely to be perceived by consumers as being state-operated, regulated or licensed and is likely to be perceived as offering the same guarantees as regulated gaming in the national territory.

Delegation of the .LOTTO gTLD would therefore likely lead to misleading of consumers as to the origin of services offered under that gTLD and it may cause consumers to take a transactional decision that they would not have taken otherwise.

Other remarks: AB Svenska Spel ("Svenska Spel") is a Swedish gaming operator wholly owned by the Swedish state. Svenska Spel provides, inter alia, the number game "Lotto" in Sweden. Lotto is one of Svenska Spel's most popular games.

Svenska Spel is the holder of two Swedish trademarks (reg. No. 351 948 and 175 193), as well as two Community trademarks (reg. No. 010972131 and 010972181), including the word Lotto - see enclosed certificates of registration.
