\n\nThere is a high demand from end users for country and territory names to assist in user-friendly navigation in order to navigate the user to a web-page of the appropriate country and language.\n\n\n\nA number of countries have expressly welcomed the development of geotargeted content by .BRAND TLDs with a focus on their national economies or language groups.\n\n\n\nThe release of country and territory names within .Neustar would provide a clear platform upon which to develop and showcase content targeted toward specific national economies or language groups.\n\n

Business Description

Describe how the Proposed Service will be offered:

\n\nNeustar intends to operate .Neustar as a .BRAND Registry, in line with the requirements set forth in Specification 13. As such, all domains under .Neustar will be registered to and controlled by Neustar, its Affiliates, or its Trademark Licensees. Neustar does not intend to sell .Neustar domain names to the general public or to allow unaffiliated third parties to control the DNS records associated with domains in .Neustar. \n\n\nThe TLD will be used to feature e-commerce and other content particular to the Neustar brand. We envision that country and territory names would be used as part of a navigation scheme to point users to relevant, geotargeted content. \n\n\nFor instance, newzealand.neustar could be used to point users from New Zealand to local product and service offerings, or other locally-relevant content.\n\n

This is a simple extension of the available namespace, anticipated by Specification 5 of the registry agreement. \r\n\r\nAccording to Specification 5, Section 4 the release of country and territory names may be approved by ICANN subject to review by ICANN's Governmental Advisory Committee (GAC). \r\n\r\n\r\nNeustar proposes that Exhibit A of the .Neustar Registry would be amended to read:\r\n\r\n\r\n"Notwithstanding Section 4 of Specification 5 of the Agreement, Registry Operator may offer registrations for and activate in the DNS the country and territory names (including their IDN variants, where applicable) contained in the following internationally recognized lists: \r\n\r\n\r\n-the short form (in English) of all country and territory names contained on the ISO 3166-1 list, as updated from time to time, including the European Union, which is exceptionally reserved on the ISO 3166-1 list, and its scope extended in August 1999 to any application needing to represent the name European Union;\r\n\r\n-the United Nations Group of Experts on Geographical Names, Technical Reference Manual for the Standardization of Geographical Names, Part III Names of Countries of the World; and\r\n\r\n-the list of United Nations member states in 6 official United Nations languages prepared by the Working Group on Country Names of the United Nations Conference on the Standardization of Geographical Names.\r\n\r\n\r\nThe relevant country and territory names are listed in Attachment 1 to Exhibit A, which is incorporated herein by this reference."\r\n\r\n
