Proposed Service

Name of Proposed Service:

Additional equitable allocation options for .mobi one and two character domains

Technical description of Proposed Service:

dotMobi initially reserved all one and two character domains on the second level in accordance with the dotMobi / ICANN contract. dotMobi proposed the release and allocation of these one and two character domains in May and November 2008 respectively, selecting an Request for Proposals (RFP) process as the equitable allocation method at that time.

dotMobi would now like to open up its allocation options to include an auction where domains remain unallocated following an RFP process and, where domains remain unallocated after both an RFP and auction phase, a first-come-first served release. This is consistent with other Registry requests regarding the release of one and two character domains (Neustar, Afilias, RegistryPro and Tralliance).

The opening up of allocation options to include an auction and a first-come-first-served process will help increase awareness of the .mobi TLD in the domain name marketplace and will enhance dotMobi's ability to compete on more even terms with TLDs that already have such a phased allocation programme in place.

dotMobi has communicated with its Policy Advisory Board [PAB] regarding this Registry request. dotMobi's PAB is made up of independent representatives from the ICANN community, including mobile and Internet experts and end-user representatives. It represents a cross-section of interests from the dotMobi sponsored community. PAB members expressed no reservations about the opening up of allocation options for one and two character .mobi domains.

b. Were consultations with gTLD registrars or the registrar constituency appropriate? Which registrars were consulted? What were the nature and content of the consultation?:

Because these additional allocation options are in line with allocation processes proposed by other Registries and subsequently approved by ICANN, dotMobi saw no need to engage in substantive consultations with gTLD Registrars or the Registrar Constituency.

c. Were consultations with other constituency groups appropriate? Which groups were consulted? What were the nature and content of these consultations?:

Because these additional allocation options are in line with allocation processes proposed by other Registries and subsequently approved by ICANN, dotMobi saw no need to consult directly with other constituency groups.

Because these additional allocation options are in line with allocation processes proposed by other Registries and subsequently approved by ICANN, dotMobi saw no need to consult directly with other constituency groups. In addition, end-users interests are represented on the PAB.

e. Who would endorse the introduction of this service? What were the nature and content of these consultations?:

The release of one and two character names via auction and a first-come-first-served process has been addressed from a technical perspective in several previously approved Registry requests (Neustar, Afilias, RegistryPro and Tralliance). Further, the gTLD Registries Stakeholder Group (RySG) is in support of the release of single character domains names provided that

dotMobi proposes the following elements for approval in connection with this registry service:

- Preparation by ICANN staff of necessary Board documentation for approval by the ICANN Board;
- Following approval by the ICANN Board, dotMobi would implement the service as soon as operationally feasible.

Business Description

Describe how the Proposed Service will be offered:

Once the previously approved RFP round has concluded, dotMobi will conduct an auction of any remaining domains according to a schedule determined by dotMobi. For any domains not allocated during either the RFP or auction rounds, dotMobi will announce a release date and will invite open, first-come-first-served registrations.

As regards the auction process, upon payment of the auction fee in full by the winning Registrant, dotMobi will provide to the successful bidder an Authorisation Code which will allow the transfer of the domain to the winning Registrant's Registrar of choice.

As regards the first-come-first-served allocation phase (if implemented), all normal second-level .mobi registration processes will apply, including the standard Registry fee.

dotMobi will conduct all necessary testing with any vendor or contractor to implement an auction.

List the relevant contractual provisions impacted by the Proposed Service:

- Schedule 6 - B. Additional Second-Level Reservations.

"In addition, the following names shall be reserved at the second level:

o All two-character labels shall be initially reserved. The reservation of a two-character label string shall be released to the extent that the Registry Operator reaches agreement with the government and country-code manager, or the ISO 3166 maintenance agency, whichever appropriate. The Registry Operator may also propose release of these reservations based on its implementation of measures to avoid confusion with the corresponding country codes".

- Secondly, Amendment No 2 to Registry Agreement (.mobi) deals with the release of one character .mobi domains.

What effect, if any, will the Proposed Service have on the reporting of data to ICANN:

dotMobi does not expect to add any additional reports to ICANN for this service and will simply report on any domain transfers carried out by virtue of any approved allocation process as is standard to reflect the second level registrations.

What effect, if any, will the Proposed Service have on the Whois?:

The WHOIS, prior to registration, includes data to show that unallocated one/ two character domains are held in a holding account by dotMobi, the same exact process that dotMobi currently uses in connection with other reserved names. Once the domain names are transferred, the Registrants will update the Whois fields as is standard and required.

Are there any Intellectual Property considerations raised by the Proposed Service:

The proposal would modestly increase the number of unique domain names to be registered in the .mobi TLD. All of the safeguards currently afforded to owners of intellectual property (eg UDRP, anti-cybersquatting laws, regulation etc) will apply to the allocation of such names. dotMobi does not believe that there are unique IP issues raised by these additional allocation options. To the extent that the parties believe that registration by another party infringes their intellectual property, ICANN has provided ample tools to resolve these claims. Nothing in this proposal undermines anyone's right to assert superior intellectual property rights in a domain.
