Name of Proposed Service:

*Second level IDN Support for Radix TLDs*

Technical description of Proposed Service:

*Radix ("Registry Operator") wishes to offer registration of IDNs at the second level under the following gTLDs: .Website, .Space, .Host, .Press, .Site, .Online, .Tech, and .Store (together the "Radix TLDs").*

*Registry Operator will offer registrars support for handling IDN registrations in EPP. Registry Operator will handle variant IDNs as follows: By default variant IDNs will be blocked from registration. Variant IDNs may be activated when requested by the sponsoring Registrar of the canonical name. Active variant IDNs will be provisioned in the TLD's DNS zone file as zone cuts using the same NS resource records as the canonical name.*

## Consultation

Please describe with specificity your consultations with the community, experts and or others. What were the quantity, nature and content of the consultations?:

*Radix's team has informally consulted with a number of relevant parties on the introduction of IDNs at the second level. We have consulted with a number of potential registrants who believe that their interests will be well served if they are able to register Internationalized Domain Names. They will be able to register names that match their native language and alphabet. We have consulted with a number of registrars who have shown a great deal of interest in offering Internationalized Domain Names under the Radix TLDs. We have consulted with various internet users generally, all of whom are very pleased with the idea of the Radix TLDs offering IDN support. It will make the Radix TLDs and the Internet generally more accommodating for a larger group of users. We have also consulted with our backend registry provider, CentralNic, about IDN support and they are very happy to implement IDN support. Further, they have experience with such an implementation and are well prepared for implementation of IDN support for the Radix TLDs. We have never received any negative feedback whatsoever on Radix offering IDN support.*

*We believe that all parties would endorse the introduction of this service as it does not have any negative effect on any parties and only offers more choice and flexibility to internet users and registrants.*

*The following provision would be added to Exhibit A of the Registry Agreements:*

### *4. Internationalized Domain Names (IDNs)*

*Registry Operator may offer registration of IDNs at the second and lower levels provided that Registry Operator complies with the following requirements: 4.1. Registry Operator must offer Registrars support for handling IDN registrations in EPP. 4.2. Registry Operator must handle variant IDNs as follows: 4.2.1. By default variant IDNs (as defined in the Registry Operator's IDN tables and IDN Registration Rules) must be blocked from registration. 4.2.2. Variant IDNs may be activated when requested by the sponsoring Registrar of the canonical name as described in the IDN Tables and IDN Registration Rules. 4.2.3. Active variant IDNs must be provisioned in the TLD's DNS zone file as zone cuts using the same NS resource records as the canonical name. 4.3. Registry Operator may offer registration of IDNs in the following languages/scripts (IDN Tables and IDN Registration Rules will be published by the Registry Operator as specified in the ICANN IDN Implementation Guidelines): 4.3.1. Arabic language 4.3.2. Cyrillic script 4.3.3. Greek script 4.3.4. Hebrew language 4.3.5. Latin script 4.3.6. Lao language 4.3.7. Thai language 4.3.8. Japanese language 4.3.9. Korean language 4.3.10. Chinese language*
