The addition of Italian and Arabic language domains to our other IDN offerings will benefit end users by expanding their ability to navigate and find relevant content in their native language.

It will also benefit Guccio Gucci by allowing us to communicate more effectively with internet users and customers in some of our most important markets.

Competition

We will operate a closed .brand registry so there will be no effect on competition in the domain name market itself.

However, the addition of IDN languages will have a positive effect on competition in the global marketplace by providing for more efficient navigation for end users of different languages.

How would you define the markets in which your proposed Registry Service would compete?:

The service itself will not compete as we are operating a closed .brand registry.

What companies/entities provide services or products that are similar in substance or effect to your proposed Registry Service?:

The Polish ccTLD registry, NASK, currently provide Italian IDNs under .pl.

A number of existing registries currently provide Arabic IDNs, including .com, .net, and the .sa ccTLD registry. Multiple new gTLD registries also intend to provide Arabic IDN registrations.

In view of your status as a registry operator, would the introduction of your proposed Registry Service potentially impair the ability of other companies/entities that provide similar products or services to compete?:

No. In fact, the opposite is true: our provision of Italian and Arabic IDNs might show other registries that there is demand by end users for navigation in these languages, encouraging them to introduce similar services.
