RE: NOTICE OF TERMINATION OF REGISTRAR ACCREDITATION AGREEMENT

Dear J. Mark Young:

Be advised that the Internet Corporation for Assigned Names and Numbers (ICANN) Registrar Accreditation Agreement (RAA) with Sundance Group, Inc. (Sundance Group) (IANA No. 1237) is terminated. As explained in greater detail below, this termination is based on Sundance Group's failure to cure a financial breach set forth in ICANN's letter dated 30 March 2009. This termination shall be effective fifteen (15) calendar days from the date of this letter, on 25 June 2009.

On 30 March 2009, ICANN sent Sundance Group a notice of breach of RAA based on Sundance Group's failure to pay the accreditation fees, as required by the RAA. Consistent with Section 5.3.4 of the RAA, Sundance Group was given fifteen (15) days to cure this breach cited in ICANN's notice of breach. Based on Sundance Group's failure to cure this cited breach within the time period specified by the RAA, Sundance Group's RAA is terminated. For your reference, a copy of ICANN's 30 March 2009 notice of breach and a current financial statement are enclosed.

ICANN's records indicate that Sundance Group does not have any domain names under management. If Sundance Group recently registered domain names, please contact ICANN's Registrar Liaison Manager, Mike Zupke mike.zupke@icann.org, to designate a bulk transfer recipient for the domain names. To facilitate a smooth transition of any domain names currently managed by Sundance Group, ICANN will follow its De-Accredited Registrar Transition Procedure (Procedure)

Please note that termination of Sundance Group's RAA does not relieve Sundance Group of the obligation to pay delinquent accreditation fees, which should be paid immediately. ICANN reserves the right to pursue all means available to collect all accreditation fees owed by Sundance Group, totaling \$7,211.87.

It is ICANN's goal to protect registrants from unnecessary harm and we look forward to amicably resolving any domain name transition issues that may arise from this termination.
