Technical description of Proposed Service:

Pursuant to Section 4 of Specification 5 of the Registry Agreement, we request the release of country and territory names within the Registry.

This request includes all such names that appear on the following lists:

- 4.1. the short form (in English) of all country and territory names contained on the ISO 3166-1 list, as updated from time to time, including the European Union, which is exceptionally reserved on the ISO 3166-1 list, and its scope extended in August 1999 to any application needing to represent the name European Union;
- 4.2. the United Nations Group of Experts on Geographical Names, Technical Reference Manual for the Standardization of Geographical Names, Part III Names of Countries of the World; and
- 4.3. the list of United Nations member states in 6 official United Nations languages prepared by the Working Group on Country Names of the United Nations Conference on the Standardization of Geographical Names.

Upon release, these names would be subject to all registration policies established for the Registry including, but not limited to, the Registry's Eligibility Requirements and Acceptable Use Policy set forth at www.nic.saxo. These policies mandate that all domains within the Registry be registered to and controlled by the Registry and its Affiliates and Trademark Licensees and feature the Registry-branded content.

We do not envision any risks to the security, stability, or resiliency of the Domain Name System associated with the release these names within the Registry.

There is a high demand from end users for country and territory names to assist in user-friendly navigation in order to navigate the user to a web-page of the appropriate country and language.

A number of countries have expressly welcomed the development of geo-targeted content by .brand TLDs with a focus on their national economies or language groups.

The release of country and territory names within the Registry would provide a clear platform upon which to develop and showcase content targeted toward specific national economies or language groups.

Describe how the Proposed Service will be offered:

The Registry intends to operate as a .BRAND Registry, in line with the requirements set forth in Specification 13. As such, all domains under the Registry will be registered to and controlled by the Registry, its Affiliates, or its Trademark Licensees. The Registry does not intend to sell domain names to the general public or to allow unaffiliated third parties to control the DNS records associated with domains in the Registry.

The TLD will be used to feature e-commerce and other content particular to the Registry brand. We envision that country and territory names would be used as part of a navigation scheme to point users to relevant, geo-targeted content. For instance, newzealand.brand could be used to point users from New Zealand to local product and service offerings, or other locally-relevant content.

- "4. Country and Territory Names. The country and territory names (including their IDN variants, where applicable) contained in the following internationally recognized lists shall be withheld from registration or allocated to Registry Operator at All Levels:
- 4.1. the short form (in English) of all country and territory names contained on the ISO 3166-1 list, as updated from time to time, including the European Union, which is exceptionally reserved on the ISO 3166-1 list, and its scope extended in August 1999 to any application needing to represent the name European Union;
- 4.2. the United Nations Group of Experts on Geographical Names, Technical Reference Manual for the Standardization of Geographical Names, Part III Names of Countries of the World; and
- 4.3. the list of United Nations member states in 6 official United Nations languages prepared by the Working Group on Country Names of the United Nations Conference on the Standardization of Geographical Names; provided, that the reservation of specific country and territory names (including their IDN variants according to the registry operator IDN registration policy, where applicable) may be released to the extent that Registry Operator reaches agreement with the applicable government(s). Registry Operator must not activate such names in the DNS; provided, that Registry Operator may propose the release of these reservations, subject to review by ICANN's Governmental Advisory Committee and approval by ICANN. Upon conclusion of Registry Operator's designation as operator of the registry for the TLD, all such names that remain withheld from registration or allocated to Registry Operator shall be transferred as specified by ICANN. Registry Operator may self-allocate and renew such names without use of an ICANN accredited registrar, which will not be considered Transactions for purposes of Section 6.1 of the Agreement."
