Amendment to Registry Agreements

THIS AMENDMENT ("Amendment"), effective as of ______ ("Amendment Effective Date"), is made by and between the Internet Corporation for Assigned Names and Numbers ("ICANN") and Charleston Road Registry Inc, and shall amend the Registry Agreement for certain top-level domains ("TLDs") in the manner as further detailed and described herein.

WHEREAS, Charleston Road Registry Inc (i) is party to the Registry Agreements identified in Appendix I (each, a "Registry Agreement") and (ii) is the Registry Operator of those TLDs identified in <u>Appendix I</u> to this Amendment, which is attached hereto and incorporated herein; and

WHEREAS, in the interest of the mutual of convenience of the parties, in lieu of executing an individual amendment to the Registry Agreement for each individual TLD, the parties hereby desire to consolidate the modifications as provided in this Amendment.

NOW THEREFORE, the parties hereto, intending to be legally bound, hereby do agree to the following:

- 1. Charleston Road Registry Inc represents it has proper authority to execute this Amendment for the purposes intended.
- 2. The Registry Agreement for those TLDs identified in Appendix I shall be amended in the manner set forth in Appendix I.
- 3. The parties hereby agree to amend Exhibit A of each of the Registry Agreements identified in Appendix I by adding the following new text as a new section 5:

"5. Registry Lock

Registry Operator may offer the Registry Lock service, which is a registry service that allows an authorized representative from the sponsoring Registrar to request the activation or deactivation of any of the following EPP statuses: serverUpdateProhibited, serverDeleteProhibited and/or serverTransferProhibited."

The parties agree that, except as set forth in this Amendment and any prior duly authorized and executed amendments, the current terms and conditions of the Agreement will remain in full force and effect. All capitalized terms not defined will have the meaning given to them in the Agreement. This Amendment may be executed in counterparts, each of which shall be deemed an original, and all of such counterparts taken together shall constitute one and the same instrument.
