Letter of motivation.

- (1) I started working in the field of Internet in 1995, and I have been involved with questions about Internet Governance and ICANN since the foundation of ICANN, and later, during the WSIS. I have been working for the Russian and the international Internet Community and have participated in many ICANN-related events, including the participation in the recent WHOIS Review Team, for many years. This experience made me realize better the strong and the weak sides of ICANN and would help to organize the work and support the success of the forming A&T Review Team.
- (2). If selected, I will make sure that the strong sides become even stronger, and the weak ones be fixed: I believe that ICANN needs even more transparency and more accountability; and especially in the time of the Affirmation of Commitments, it needs to engage even more the broad Internet community.
