## RE: NOTICE OF TERMINATION OF REGISTRAR ACCREDITATION AGREEMENT

Dear Manetirony Clervrain:

Be advised that the Internet Corporation for Assigned Names and Numbers (ICANN) Registrar Accreditation Agreement (RAA) with Clertech.com Inc.

(Clertech.com Inc.) (IANA No. 1399) is terminated. As explained in greater detail below, this termination is based on Clertech.com Inc.'s failure to cure a financial breach set forth in ICANN's letter dated 2 December 2008. This termination shall be effective fifteen (15) calendar days from the date of this letter, on 25 June 2009.

Clertech.com Inc. is further advised that the logo license Appendix to the above mentioned RAA is revoked. ICANN demands that Clertech.com Inc. remove all ICANN Trademarks immediately from Clertech.com Inc.'s website and business materials that have been licensed to Clertech.com Inc. under the terms of that appendix.

On 2 December 2008, ICANN sent Clertech.com Inc. a notice of breach of RAA based on Clertech.com Inc.'s failure to pay the accreditation fees, as required by the RAA. Consistent with Section 5.3.4 of the RAA, Clertech.com Inc. was given fifteen (15) working days to cure this breach. Based on Clertech.com Inc.'s failure to cure this breach within the time period specified by the RAA, Clertech.com Inc.'s RAA is terminated. For your reference, a copy of ICANN's 2 December 2008 notice of breach and a current financial statement are enclosed.

ICANN's records indicate that Clertech.com Inc. does not have any domain names under management. If Clertech.com Inc. recently registered domain names, please contact ICANN's Registrar Liaison Manager, Mike Zupke <a href="mike.zupke@icann.org">mike.zupke@icann.org</a>, to designate a bulk transfer recipient for the domain names. To facilitate a smooth transition of any domain names currently managed by Clertech.com Inc. ICANN will follow its De-Accredited Registrar Transition Procedure (Procedure)

We encourage you to read the Procedure in its entirety. Consistent with the Procedure, we are requesting that Clertech.com Inc. designate a bulk transfer recipient on or before 15 June 2009.

Please note that termination of Clertech.com Inc.'s RAA does not relieve Clertech.com Inc. of the obligation to pay delinquent accreditation fees, which should be paid immediately. ICANN reserves the right to pursue all means available to collect these fees, totaling \$8,277.69.

It is ICANN's goal to protect registrants from unnecessary harm and we look forward to amicably resolving any domain name transition issues that may arise from this termination.
