Re: Notice of Breach of Registrar Accreditation Agreement

Dear Mr. Bordes:

Be advised that as of 4 February 2009, DropLimited.com, Inc. (DropLimited.com) is in breach of the Internet Corporation for Assigned Names and Numbers ("ICANN") Registrar Accreditation Agreement ("RAA"). This breach results from DropLimited.com's failure to escrow gTLD registration data pursuant to Section 3.6 of the RAA, to provide interactive web-based and port 43 Whois service pursuant to Section 3.3.1, et seq., of the RAA, and to pay accreditation fees to ICANN, as due, pursuant to Section 3.9 of the RAA.

Section 3.6 of the RAA requires DropLimited.com, "on a schedule, under the terms, and in the format specified by ICANN" to "submit an electronic copy of the database described in Subsection 3.4.1 [of the RAA] to ICANN or, at Registrar's election and at its expense, to a reputable escrow agent mutually approved by Registrar and ICANN."

ICANN notified DropLimited.com by facsimile on 18 December 2007 of DropLimited.com's obligation to begin escrowing certain enumerated gTLD registration data by no later than 1 May 2008, and thereafter on a weekly basis, in accordance with the Registrar Data Escrow Specifications document posted at http://www.icann.org/rde/rde-specs-09nov07.pdf. You acknowledged this obligation by executing the Registrar Data Escrow Agreement between DropLimited.com, Inc., ICANN, and Iron Mountain Intellectual Property Management, Inc. on 6 March 2008. To date, no deposits have been made in furtherance of your registrar's escrow obligation.

DropLimited.com's failure to escrow registration data with Iron Mountain Intellectual Property Management, Inc. constitutes a breach of Section 3.6 of the RAA.

Sections 3.3.1, et seq., of the RAA require DropLimited.com to "provide an interactive web page and a port 43 Whois service providing free public query-based access to up-to-date (i.e., updated at least daily) data concerning all active Registered Names sponsored by Registrar for each TLD in which it is accredited," such data to include:

- 3.3.1.1 The name of the Registered Name;
- 3.3.1.2 The names of the primary nameserver and secondary nameserver(s) for the Registered Name;

- 3.3.1.3 The identity of Registrar (which may be provided through Registrar's website);
- 3.3.1.4 The original creation date of the registration;
- 3.3.1.5 The expiration date of the registration;
- 3.3.1.6 The name and postal address of the Registered Name Holder;
- 3.3.1.7 The name, postal address, e-mail address, voice telephone number, and (where available) fax number of the technical contact for the Registered Name; and
- 3.3.1.8 The name, postal address, e-mail address, voice telephone number, and (where available) fax number of the administrative contact for the Registered Name.

You were notified by email on 15 January 2009 that DropLimited.com's web-based and port 43 Whois services were non-functional. As of 27 January 2009, queries of DropLimited.com's whois services for the following domain names demonstrate that DropLimited.com remains non-compliant with regard to Section 3.3.1 of the RAA:

DropLimited.com's failure to provide both web-based Whois service and Whois service via port 43 constitutes a breach of Section 3.3.1 of the RAA.

Section 3.9 of the RAA requires DropLimited.com to timely pay accreditation fees to ICANN, consisting of yearly and variable fees.

On 22 January 2008, ICANN notified your registrar's primary contact Richard Lau by email that its account with ICANN was over 30 days past due, with \$1,990.63 owing. On 3 March 2008, a Notice of Breach of Registrar Accreditation Agreement was transmitted to Mr. Lau by courier, for failure to pay \$5,198.22 in accreditation fees. The invoices totaling \$1,990.63 (numbered 13582 and 14879) and cited in the prior Notice of Breach, remain unpaid.

Since the prior Notice of Breach, DropLimited.com has failed to make payment on four additional invoices, numbered 16481, 17291, 18659, and 20038, for \$4,000.00, \$1,128.13, \$1,661.82, and \$1,076.03, respectively, all of which are now over 30 days past due.

DropLimited.com's failure to make timely payment on invoice numbers 13582, 14879, 16481, 17291, and 18659 constitutes numerous breaches of Section 3.9 of the RAA.

Be advised that, should DropLimited.com fail to cure the breaches cited herein within 15 working days, ICANN may commence the termination process as set forth in the RAA. Furthermore, ICANN's right to seek specific performance of DropLimited.com's obligations under the RAA through litigation or arbitration is not constrained by the above-referenced cure period.

Finally, this notice of breach of the RAA is made without prejudice to any and all rights and remedies available to ICANN, including, without limitation, ICANN's previous termination rights related to DropLimited.com's failure to pay invoices 13582 and 14879 as set forth in ICANN's Notice of Breach transmitted on 3 March 2008. ICANN specifically reserves the right to pursue any and all other breaches in addition to the breaches enumerated above, and nothing herein shall be deemed a waiver of that right.

ICANN was notified by VeriSign that on 15 December 2008, it sent DropLimited.com a Notice of Breach of its Registry Registrar Agreement. Further, ICANN was copied on VeriSign's 3 February 2009, Notice of Termination letter transmitted to DropLimited.com. It is ICANN's understanding that the termination has resulted in restricted access for DropLimited.com to the .com and .net Shared Registration Systems.

Given the potential harm that may be caused to registrants by your registrar's continued failure to cure breaches cited in this letter and your registrar's restricted access to the .com and .net Shared Registration Systems, I recommend you to contact me by telephone or email within the next 48 hours to establish a timeline for compliance that may allow your registrar to avoid legal action.
