RE: NOTICE OF BREACH OF REGISTRAR ACCREDITATION AGREEMENT

Dear Mr. Al-Abdulhadi,

Please be advised that as of 22 November 2013, KuwaitNET General Trading Co. ("KuwaitNET") is in breach of its Registrar Accreditation Agreement ("RAA") with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 7 December 2009 ("RAA"). These breaches result from:

- KuwaitNET's failure to timely respond to ICANN's Contractual Compliance Audit Program ("Audit") notices, specifically:
 - a. Failure to provide documents and information as required by the terms of Section 3.14: and
 - b. Failure to maintain records relating to KuwaitNET's dealings with Registry Operator(s) and Registered Name Holders and to make such records available to ICANN for inspection, pursuant to Sections 3.4.2 and 3.4.3 of the RAA.
- 2. KuwaitNET's failure to pay past due accreditation fees pursuant to Section 3.9 of the RAA

ICANN requests that KuwaitNET cure the breaches by 17 December 2013, 15 working days from the date of this letter, by taking the following actions:

- 1. Complete the Audit Request for Information (RFI) Phase, by:
 - a. Contacting complianceaudit@icann.org to receive your registrar's login credentials for the ICANN Compliance Site ("Site"); and
 - b. Completing the RFI and providing all supporting documentation through the Site.
- 2. Pay all past due accreditation fees of \$1,000.00.

If KuwaitNET fails to timely cure the breaches and provide the information requested, ICANN may commence the termination process.

ATTACHMENT

Failure to Provide Documents and Information for Audit and to Make Records Relating to Registered Name Holders Available to ICANN

Section 3.14 of the RAA requires KuwaitNET, as part of any reasonable contractual compliance audit, to timely provide the documents and information known by KuwaitNET necessary to demonstrate compliance with the terms of this Agreement. Section 3.4.2 of the RAA requires KuwaitNET to maintain registration data and records relating to its dealings with Registered Name Holders and with the Registry Operator(s) for every domain name under KuwaitNET's management. Section 3.4.3 of the RAA requires KuwaitNET to make these records and data available to ICANN upon reasonable notice.

As detailed in the chronology below, since 1 October 2013 ICANN sent KuwaitNET three notices regarding the requirements of ICANN's Audit Program. To date, KuwaitNET has not responded to any Audit Program communication and has not contacted ICANN regarding the Audit Program.

Failure to Pay Accreditation Fees

Section 3.9 of the RAA requires registrars to timely pay accreditation fees to ICANN, consisting of yearly and variable fees. KuwaitNET owes ICANN \$1,000.00 in past due accreditation fees, in breach of Section 3.9 of the RAA.
