PLEASE TAKE NOTICE that at 1:30 p.m. on October 6, 2003 or as soon thereafter as counsel may be heard in Courtroom 16 of the above entitled Court, located at located at 312 N. Spring Street, Dept. 16, Los Angeles, CA 90012, the Honorable John F. Walter presiding, Plaintiffs DOTSTER, INC., GODADDY SOFTWARE, INC., and eNOM, INC. ("Plaintiffs") will and hereby do move this Court, pursuant to Fed. R. Civ. Pro. 65, for a preliminary injunction against Defendant INTERNET CORPORATION FOR ASSIGNED NAMES AND NUMBERS ("ICANN") enjoining ICANN, its agents, servants, and employees, all person acting or purporting to act under its authority, direction, or control, and all persons acting in concert or in participation with it who receive notice of the preliminary injunction from:

- (1) taking any steps or actions to facilitate or encourage the implementation of a proposed Wait List Service ("WLS"), as further described in the Complaint and moving papers, including, but not limited to further steps or action to negotiate or execute an amendment to the Registry Agreement, or any of its exhibits, between the Defendant and VeriSign, Inc., attached to the first Declaration of Clint Page as Exhibit B, which in any way would facilitate or encourage the implementation of WLS; and
- (2) taking any further steps or actions which would constitute a breach of the terms of any of the Registrar Accreditation Agreements (See Exhibit 1 to Plaintiff's Complaint) between the Defendant and any of the Plaintiffs, including but not limited to Section 4 of those Agreements regarding Procedures for Establishment for Revision of Specifications and Policies.

This motion is based on this Notice of Motion and Motion, Plaintiffs'
Memorandum of Points and Authorities in support thereof, the declarations of Clint
Page, Paul Stahura, Robert Parsons, Tim Ruiz, Sharon K. Dunham, Thomas Bennett,
