Nomination letter

Dear Mr. Chehade

It is my great pleasure to write you this letter as a Government authority.

I am writing this letter regarding the "MN" country code top level domain and the "MOH" internationalized domain name. Just to inform you that "Datacom" Co.Ltd, private company has been handling the .MN ccTLD's distribution and administration in Mongolia for a long time. However, with current development of Internet, .MN domain name development is insufficient because there has not been developed government policy and regulation on this field until today, as well as Mongolian internet and domain name users are complaining about services of "Datacom". /We don't even have any statistics about .MN domain name/. In such reasons, Government of Mongolia has decided to have certain policy on .MN domain name and amended Government Resolution which is attached within.

According to the Resolution, Government of Mongolia has decided to develop policy on .MN domain name considering that the Communications Regulatory Commission (CRC) of Mongolia is the most appropriate authority to implement the regulation of .MN and .MOH domain names. As you may know that CRC is an independent Regulatory Authority, which is responsible for regulation of ICT sector including Broadcasting and Internet.

Depending on this Government Resolution, CRC is arranging meetings with "Datacom" Co.Ltd, and discussing about the current situation and conducting open consultations within Mongolian internet users/stakeholders for several times. We assume that they will have some results on how to coordinate and regulate this domain name related issue.

Meantime, I'm kindly requesting to change the representative of the Government of Mongolia, Mr. Enkhbat Dangaasuren, to the Governmental Advisory Committee of ICANN because he is not a Member of Parliament anymore so that he is not able to be a representative of the Governmental of our country from our perspectives.

In order to implement the above mentioned Government Resolution, I would like to officially nominate Mr. Balgansuren Batsukh, Chairman of the Communications Regulatory Commission as a representative of Mongolia to the Governmental Advisory Committee of ICANN.


This is what I am requesting your kind approval and confirmation and I would appreciate your kind attention to this matter.

Regarding "Joint System for Website Comments"

Pursuant to the article 7 of the section 2 of the Law on Government, it is SOLVED by the Government of Mongolia:

- 1. To assign Jadambaa Ts., an acting chairman of the Information, Communications Technology and Post Authority to create a "Joint System for Website Comments", take measures to develop and implement software and technical solutions of the system, and establish agreements and contracts with mobile operators or mobile service operators and related organizations in relation to ensuring a sustainable operation of the system under the appropriate procedure with the purpose of using website comments properly;
- 2. To assign Balgansuren B., the Communications Regulatory Commission to define requirements for websites that conduct activities concerning the news and information and granting domain names, and take measures to develop the regulatory procedure in compliance with legislations and enforce thereof:
- 3. To oblige Purevdorj an acting chairman of the General Authority for State Registration and Gerel D., a head of the General Intelligence Agency to provide with information related to civil registrations and legal entities required for creating and using a database of "Joint System for Website Comments":
- 4. Oblige Jadambaa Ts., an acting chairman of the Information, Communications Technology and Post Authority to take measures to ensure a reliable and regular operation of software and equipment for checking or inspecting and using information related to website comments and Temuujin Kh., a Ministry of Justice to investigate the suspect who left comments with behavior of; insult, sexual seductions, threatening attitude and crime in accordance in case a complaint and take legal measures to the suspect who left inappropriate comments;
- 5. To assign Jadambaa Ts., an acting chairman of the Information, Communications Technology and Post Authority to specify investment and operational costs in an annual budget required for introducing "Joint System for Website Comments";
