RE: NOTICE OF TERMINATION OF REGISTRAR ACCREDITATION AGREEMENT

Dear Ms. Bullock,

Please be advised that C I Host, Inc.'s ("C I Host") Registrar Accreditation Agreement ("RAA") with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 4 Feb 2012 ("RAA") is terminated pursuant to Section 5.3.7 of the RAA. Consistent with RAA Section 5.3 Termination of Agreement by ICANN, this termination is effective immediately.

This termination is based on C I Host's seeming insolvency. ICANN came to this conclusion based on the following:

1. The contact details provided to ICANN by CI Host (telephone numbers, fax number and address) are no longer valid, in violation of RAA Section 5.11 Notices, Designations, and Specifications;
2. An article published by D Magazine states that another entity purchased the office space where C I Host allegedly operates. To see the article, go to: <http://realpoints.dmagazine.com/2012/03/corespace-moving-headquarters-to-dallas/>;
3. C I Host's failure to provide an interactive webpage, in violation of RAA Section 3.3 Public Access to Data on Registered Names (www.cishost.com does not resolve); and
4. C I Host's failure to timely pay accreditation fees for several months, in violation of RAA Section 3.9 Accreditation Fees (see the attached customer statement).

In addition, please pay the outstanding accreditation fees totaling \$9,478.16 immediately. See the attached customer statement for details.

Domain Name Transition Process

To protect domain name registrants, ICANN will commence the domain name transition process and will solicit bids for a qualified ICANN-accredited registrar to manage the domain names currently managed by C I Host.

ICANN will follow the De-Accredited Registrar Transition Procedure "Procedure" <http://www.icann.org/en/processes/registrars/de-accredited-registrar-transition-procedure-01oct08.pdf> . Consistent with the Procedure, please designate a bulk transfer recipient by 6 March 2013 and inform ICANN's Registrar Liaison Team at RegTransition@icann.org.

ICANN reserves all of its rights under the RAA. Please note the rights and obligations required to have effect after the expiration of the RAA, including but not limited to, Sections 3.4 Retention of Registered Name Holder and Registration Data, 3.9 Accreditation Fees, 5.6 Resolution of Disputes Under this Agreement and 5.7 Limitations on Monetary Remedies for Violations of this Agreement.

The telephone was answered by an employee of a company named Corespace. ICANN staff asked to speak with C I Host's primary contact, Erin Bullock. The employee stated that no one worked at Corespace named Erin Bullock. When asked whether Corespace is affiliated with CI Host, the employee stated that Corespace purchased some of CI Host's asset, but Corespace is not affiliated with CI Host. The number was deemed invalid. |
