RE: NOTICE OF BREACH OF REGISTRAR ACCREDITATION AGREEMENT

Dear Ms. Ivanova,

Please be advised that as of 30 April 2014, DomReg Ltd. d/b/a LIBRIS.COM (“DomReg”) is in breach of its Registrar Accreditation Agreement (“RAA”) with the Internet Corporation for Assigned Names and Numbers (“ICANN”) dated 19 November 2011 (“RAA”). This breach results from:

- DomReg’s failure to provide the AuthInfo code within 5 calendar days to the Registered Name Holder (“RNH”) of the domain name <promat.com>, pursuant to Section 5 of the Inter-Registrar Transfer Policy (“IRTP”).

Please refer to the attachment for details regarding this breach.

In addition, DomReg has been deemed noncompliant in the following areas:

- Failure to timely pay past due accreditation fees in the amount of \$959.57, as required by Section 3.9 of the RAA.

ICANN requests that DomReg cure the breach by 21 May 2014, 15 working days from the date of this letter, by taking the following actions:



- Provide the AuthInfo code to the RNH of the domain name <promat.com>, pursuant to Section 5 of the IRTP; and
- Pay past due accreditation fees in the amount of \$959.57.

If DomReg fails to timely cure this breach and provide the information requested by 21 May 2014, ICANN may commence the RAA termination process.

ATTACHMENT

Failure to Provide AuthInfo Code within 5 Calendar Days

Paragraph 5 of the IRTP requires DomReg to provide the RNH with the unique AuthInfo code within five (5) calendar days of the RNH's initial request. Registrars can only deny a transfer request for the reasons listed in Section 3 of the IRTP. Specifically, Section 3.3 of the IRTP states that registrars may deny a transfer based upon a court order issued by a court of competent jurisdiction. Section 3.4 of the IRTP states that registrars may deny a transfer if there is reasonable dispute over the identity of the RNH or Administrative Contact.

DomReg did not provide the AuthInfo code to the RNH within 5 days from the date of the initial request. DomReg did not provide a valid court order upon request from ICANN. DomReg did not demonstrate to ICANN that there was a reasonable dispute that the entity requesting the transfer is not the RNH or Administrative Contact. DomReg's failure to provide the AuthInfo code within five (5) days of the Registered Name Holder's request concerning domain name <promat.com> constitutes a breach of Section 5 of the IRTP.

Failure to Pay Accreditation Fees

Section 3.9 of the RAA requires registrars to timely pay accreditation fees to ICANN, consisting of yearly and variable fees. DomReg owes ICANN \$959.57 in past due accreditation fees, in breach of Section 3.9 of the RAA.
