RE: NOTICE OF TERMINATION OF ACCREDITATION AGREEMENT

Dear Mr. Miller,

Please be advised that as of 30 July 2015, USA Intra Corp.'s ("USA Intra") Registrar Accreditation Agreement ("RAA") with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 31 August 2011 ("RAA") is terminated pursuant to Section 5.3.4 of the RAA. The termination shall become effective 20 August 2015, 15 business days from the date of this notice.

The termination is due to USA Intra's failure to timely cure the breaches by 6 July 2015 as set forth in ICANN's notice of breach of RAA dated 15 June 2015. As of 30 July 2015, the following breaches remain:

1. USA Intra's failure to notify ICANN of a change to its contact information within thirty (30) days, as required by Section 5.11 of the RAA;
2. USA Intra's failure to provide ICANN with documentation that USA Intra is in good standing in its jurisdiction of incorporation and is not bankrupt or insolvent;
3. USA Intra's failure to maintain current commercial general liability insurance, as required by Section 3.10 of the RAA; and

4. USA Intra's failure to timely pay past due accreditation fees in the amount of \$6,552.26, as required by Section 3.9 of the RAA.

USA Intra is further advised that the logo license granted in the Logo License Appendix to the RAA is revoked as of 20 August 2015. Please remove all ICANN trademarks, name and logo from USA Intra's website and business materials that have been licensed to USA Intra under the terms of that appendix by 20 August 2015.

Domain Name Transition Process

Because no domains are currently managed by USA Intra, ICANN does not need to follow the [De-Accredited Registrar Transition Procedure](#) ("Procedure").

ICANN reserves all its rights under the RAA. Please note the rights and obligations required to have effect after the expiration of the RAA, including but not limited to Sections 3.4 Retention of Registered Name Holder and Registration Data, 3.9 Accreditation Fees, 5.6 Resolution of Disputes Under this Agreement and 5.7 limitations on Monetary Remedies for Violations of this Agreement.

USA Intra has past due accreditation fees in the amount of \$6,552.26. These fees are required to be paid to ICANN by Section 3.9 of the RAA. Please immediately submit payment to ICANN accounting.
