RE: NOTICE OF BREACH OF REGISTRAR ACCREDITATION AGREEMENT

Dear Mr. Mingyi,

Please be advised that as of 28 May 2013, AsiaRegister, Inc. (“AsiaRegister”) is in breach of its Registrar Accreditation Agreement (“RAA”) with the Internet Corporation for Assigned Names and Numbers (“ICANN”) dated 23 March 2011 (“RAA”). This breach results from:

- Failure to pay past due accreditation fees pursuant to Section 3.9 of the RAA.

Please refer to the attachment for details regarding this breach. In addition, AsiaRegister has been deemed noncompliant in the following area:

- Failure to display a link to ICANN’s Registrant Rights and Responsibilities webpage on AsiaRegister’s website, as required by Section 3.15 of the RAA.

ICANN requests that AsiaRegister cure these breaches by 18 June 2013, 15 working days from the date of this letter, by taking the following actions:

1. Pay all past due accreditation fees in the amount of \$16,362.64. Please see the enclosed customer statement for details; and
2. Clearly display a link to ICANN’s Registrant Rights and Responsibilities webpage on AsiaRegister’s website.

ATTACHMENT

1. Failure to Pay Accreditation Fees

Section 3.9 of the RAA requires registrars to timely pay accreditation fees to ICANN, consisting of yearly and variable fees. AsiaRegister currently owes ICANN \$16,362.64 in past due accreditation fees.

AsiaRegister failed to comply with its obligation to timely pay accreditation fees and this failure constitutes a breach of Section 3.9 of the RAA.
