**RE: NOTICE OF BREACH OF REGISTRAR ACCREDITATION AGREEMENT**

Dear Mr. Moran,

Please be advised that as of 4 February 2014, Black Ice Domains, Inc. (“Black Ice”) is in breach of its Registrar Accreditation Agreement (“RAA”) with the Internet Corporation for Assigned Names and Numbers (“ICANN”) dated 18 January 2011 (“RAA”). This breach results from:

1. Black Ice’s failure to pay past due accreditation fees pursuant to Section 3.9 of the RAA.

Please refer to the attachment for details regarding these breaches.

ICANN requests that Black Ice cure the breach by 25 February 2014, 15 working days from the date of this letter, by taking the following actions:

1. Pay all past due accreditation fees of \$6,916.42.

ICANN may commence the termination process if Black Ice fails to timely cure the breach.

### Failure to Pay Accreditation Fees

Section 3.9 of the RAA requires registrars to timely pay accreditation fees to ICANN, consisting of yearly and variable fees. Black Ice owes ICANN \$6,916.42 in past due accreditation fees, in breach of Section 3.9 of the RAA.
