RE: NOTICE OF BREACH OF REGISTRAR ACCREDITATION AGREEMENT

Dear Mr. Moran,

Please be advised that as of 5 February 2013, Black Ice Domains, Inc. (“Black Ice”) is in breach of its Registrar Accreditation Agreement (“RAA”) with the Internet Corporation for Assigned Names and Numbers (“ICANN”) dated 18 January 2011 (“RAA”). This breach results from:

- Black Ice’s failure to provide ICANN with a requested document within fifteen (15) days as required by Section 5.9.2 of the RAA.

Please refer to the attachment for details regarding this breach.

ICANN requests that Black Ice cure the breach by 26 February 2013, 15 working days from the date of this letter, by taking the following action:

1. Provide ICANN with a copy of the Purchase Agreement regarding your recent acquisition of Black Ice.

If Black Ice fails to timely cure this breach and provide the information requested, ICANN may commence the RAA termination process.

ATTACHMENT

Failure to Provide ICANN with Requested Information within Fifteen (15) Days

Concerning assignments and changes of ownership or management, Section 5.9.2 of the RAA requires Black Ice to provide ICANN with additional information, if requested, to establish compliance with the RAA. Pursuant to this provision, Black Ice is required to supply the requested information within fifteen (15) days after ICANN's request.

On 5 October 2012, ICANN sent its first request to Black Ice for a copy of the Purchase Agreement related to your purchase of Black Ice. Over the next three months, ICANN sent three more compliance notices and engaged in a telephone conversation with a registrar representative regarding ICANN's request for a copy of the Purchase Agreement. As of the date of this notice, Black Ice has not provided the requested Purchase Agreement and is in breach of Section 5.9.2 of the RAA.
