RE: NOTICE OF BREACH OF REGISTRAR ACCREDITATION AGREEMENT

Dear Mr. Patel,

Please be advised that as of 16 December 2013, BRANDON GRAY INTERNET SERVICES INC. (dba "NameJuice.com") ("Brandon Gray") is in breach of its Registrar Accreditation Agreement ("RAA") with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 12 February 2009 ("RAA"). This breach results from:

- Brandon Gray's failure to maintain and make available to ICANN registration records relating to dealings with the Registered Name Holder, pursuant to Sections 3.4.2 and 3.4.3 of the RAA

Please refer to the attachment for details regarding these breaches.

ICANN requests that Brandon Gray cure the breach by 13 January 2014, 15 working days from the date of this letter, by taking the following actions:

- Provide ICANN with the registration data and written communications concerning the domain name <businesspotion.com> for the period 22 July 2013 to present, between Brandon Gray and the Registered Name Holder, including a copy of the registration agreement entered between Brandon Gray and the Registered Name Holder of the account.

ATTACHMENT

Failure to Maintain and Make Records Relating to Registered Name Holders Available to ICANN

Section 3.4.2 of the RAA requires Brandon Gray to maintain registration data and records relating to its dealings with Registered Name Holders and with the Registry Operator(s) for every domain name under Brandon Gray's management. Section 3.4.3 of the RAA requires Brandon Gray to make these records and data available to ICANN upon reasonable notice.

As detailed in the chronology below, since 28 October 2013 ICANN sent Brandon Gray three notices requesting registration data and records. To date, Brandon Gray has not provided these documents.
