RE: NOTICE OF BREACH OF REGISTRAR ACCREDITATION AGREEMENT

Dear Mr. Savita,

Please be advised that as of 19 February 2015, Tirupati Domains and Hosting Pvt Ltd. (“Tirupati”) is in breach of its Registrar Accreditation Agreement (“RAA”) with the Internet Corporation for Assigned Names and Numbers (“ICANN”) dated 31 March 2010 (“RAA”). This breach results from:

1. Tirupati’s failure to timely pay past due accreditation fees in the amount of \$3,808.74, as required by Section 3.9 of the RAA.

Please refer to the attachment for details regarding this breach.

ICANN requests that Tirupati cure these breaches by 12 March 2015, 15 business days from the date of this letter, by taking the following action:

1. Immediately pay all past and currently due accreditation fees of \$4,666.83.

Failure to pay accreditation fees

Section 3.9 of the RAA requires registrars to timely pay accreditation fees to ICANN, consisting of yearly and variable fees. Tirupati owes ICANN \$3,808.74 in past due accreditation fees, in breach of Section 3.9 of the RAA. Tirupati additionally owes \$858.09 in currently due accreditation fees, due 1 March 2015.
