**RE: NOTICE OF BREACH OF REGISTRAR ACCREDITATION AGREEMENT**

Dear Mr. van Hoegge,

Please be advised that as of 11 September 2014, Domain Services Rotterdam BV (“Domain Services Rotterdam”) is in breach of its Registrar Accreditation Agreement (“RAA”) with the Internet Corporation for Assigned Names and Numbers (“ICANN”) dated 22 March 2014 (“RAA”). This breach results from:

- Domain Service Rotterdam’s failure to pay past due accreditation fees, pursuant to Section 3.9 of the RAA.

Please refer to the attachment for details regarding this breach.

ICANN requests that Domain Services Rotterdam cure the breach by 2 October 2014, 21 calendar days from the date of this letter, by taking the following actions:

- Pay all past due accreditation fees of \$4,763.91.

If Domain Services Rotterdam fails to timely cure the breaches by 2 October 2014, ICANN may commence the RAA termination process.

### Failure to Pay Accreditation Fees

Section 3.9 of the RAA requires registrars to timely pay accreditation fees to ICANN, consisting of yearly and variable fees. Domain Services Rotterdam owes ICANN \$4,763.91 in past due accreditation fees, in breach of Section 3.9 of the RAA.
