**RE: NOTICE OF TERMINATION OF ACCREDITATION AGREEMENT**

Dear Mr. van Hoegge,

Please be advised that as of 24 October 2014, Domain Services Rotterdam BV's ("Domain Services Rotterdam") Registrar Accreditation Agreement ("RAA") with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 22 March 2014 ("RAA") is terminated pursuant to Section 5.5.4 of the RAA. The termination shall become effective 21 November 2014, 28 days from the date of this notice.

The termination is due to Domain Services Rotterdam's failure to timely cure the breaches by 2 October 2014 as set forth in ICANN's notice of breach of RAA dated 11 September 2014. As of 24 October 2014, the following breach remains:

1. Domain Service Rotterdam's failure to pay past due accreditation fees, pursuant to Section 3.9 of the RAA.

Please see the chronology below for additional details.

Domain Services Rotterdam is further advised that the logo license granted in the Logo License Specification to the RAA is revoked as of 21 November 2014. Please remove all ICANN trademarks,



name and logo from Domain Services Rotterdam's website and business materials that have been licensed to Domain Services Rotterdam under the terms of that specification by 21 November 2014.

#### Domain Name Transition Process

Because no domains are currently managed by Domain Services Rotterdam, ICANN does not need to follow the [De-Accredited Registrar Transition Procedure](#) ("Procedure").

ICANN reserves all its rights under the RAA. Please note the rights and obligations required to have effect after the expiration of the RAA, including but not limited to Sections 3.4 Retention of Registered Name Holder and Registration Data, 3.9 Accreditation Fees, 5.8 Resolution of Disputes Under this Agreement and 5.9 limitations on Monetary Remedies for Violations of this Agreement.

Domain Services Rotterdam has current and past due accreditation fees in the amount of \$5,118.83. These fees are required to be paid to ICANN by Section 3.9 of the RAA. Please immediately submit payment to ICANN accounting.
