RE: NOTICE OF BREACH OF REGISTRAR ACCREDITATION AGREEMENT

Dear Ms. Wang,

Please be advised that as of 9 September 2014, Tong Ji Ming Lian (Beijing) Technology Corporation Ltd. (“Trename”) is in breach of its Registrar Accreditation Agreement (“RAA”) with the Internet Corporation for Assigned Names and Numbers (“ICANN”) dated 10 August 2010 (“RAA”). This breach results from:

- Trename’s failure to pay past due accreditation fees, pursuant to Section 3.9 of the RAA.

Please refer to the attachment for details regarding this breach.

In addition, Trename has been deemed noncompliant in the following areas:

1. Failure to provide an interactive web page and a port 43 Whois service providing free public query-based access to up-to-date data concerning all active Registered Names sponsored by Registrar for each top-level domain (“TLD”) in which it is accredited, pursuant to Section 3.3.1 of the RAA; and
2. Failure to notify ICANN of a change to its contact information within thirty (30) days, as required by Section 5.11 of the RAA.

ICANN requests that Trename cure the breach by 30 September 2014, 15 working days from the date of this letter, by taking the following actions:

1. Pay all past due accreditation fees of \$2,252.56;
2. Provide an interactive web page and a port 43 Whois service providing free public query-based access to up-to-date data concerning all active Registered Names sponsored by Registrar for each TLD in which it is accredited in accordance with Section 3.3.1 of the RAA; and
3. Provide ICANN with written notification of updated contact information in accordance with Section 5.11 of the RAA.

If Trename fails to timely cure the breaches and provide the information requested by 30 September 2014, ICANN may commence the RAA termination process.

ATTACHMENT

Failure to Pay Accreditation Fees

Section 3.9 of the RAA requires registrars to timely pay accreditation fees to ICANN, consisting of yearly and variable fees. Trename owes ICANN \$2,252.56 in past due accreditation fees, in breach of Section 3.9 of the RAA.

Failure to provide an interactive web page and a port 43 Whois service

Section 3.3.1 of the RAA requires registrars to provide an interactive web page and a port 43 Whois service providing free public query-based access to up-to-date data concerning all active registered names sponsored by the registrar. Trename's failure to provide an interactive web page and port 43 Whois service is a breach of Section 3.3.1 of the RAA.

Failure to notify ICANN of changes to its contact information

Section 5.11 of the RAA requires registrars to provide written notification to ICANN within thirty (30) days of any change to its contact information. Trename's failure to provide ICANN with written notice of changes to its contact information is a breach of Section 5.11 of the RAA
