Operating Plan and Budget	The BFC reviewed and provided input on the FY19 Operating plan and Budget planning timeline and process for PTI and ICANN that was proposed by ICANN Staff. In doing so, the BFC ensured that necessary and appropriate engagement with the Community and the Board had been included in the plan.	July 2017 thru December 2017	Through the input and guidance provided during the review of each milestone of the annual planning process, the BFC has ensured that the fiduciary responsibility of the Board is adequately fulfilled and has ensured that optimal community engagement is planned to occur to deliver transparent operating planning documents that demonstrate ICANN's accountability for the public benefit. During ICANN 60 in Abu Dhabi, a Budget working group session was held with the community to review and discuss the FY19 Operating Plan and Budget process and assumptions. Member of the BFC and the BFC Chair attended this meeting.

Financial Statement Review and Review of Funds Under Management	The BFC reviewed the FY17 Year End Financial Statements and the FY18 Quarterly Financial Statements. The BFC also reviewed the Funds Under Management schedules during its regular meetings and at a minimum once per quarter. The BFC discussed the replenishment of the Reserve Fund.	July 2017 thru December 2017	The BFC discussed and reviewed the FY17 Year End Financial Statements. The BFC also reviewed the status of the Funds Under Management.
Contracting and Disbursement Approvals	The BFC evaluated the financial aspects of all required contracting and disbursement decisions for items exceeding the CEO's authority of US\$500,000 during July through December FY17. The financial aspects evaluated by the BFC were (i) that costs are reasonable, (ii) that the procurement process was respected, and (iii) that the costs were affordable. The BFC had a joint meeting with the BRC to review the Information Transparency Initiative (ITI) project. The BFC recommended approval for the contracting requirements for the ITI project.	July 2017 thru December 2017	BFC discussed and recommended approval by the Board of Disbursements on two contracts: <ol style="list-style-type: none"> 1) Contracting for the June 2019 ICANN Policy Forum Marrakech, Morocco and 2) The Zensar Contract Extension 3) Information Transparency Initiative (ITI)
