RE: NOTICE OF BREACH OF REGISTRAR ACCREDITATION AGREEMENT

Dear Mr. Moll:

Be advised that as of 15 April 2010, Western United Domains, Inc. ("Western United Domains") is in breach of the Internet Corporation for Assigned Names and Numbers' Registrar Accreditation Agreement ("RAA"). This breach results from Western United Domains' failure to escrow gTLD registration data pursuant to Section 3.6 of the RAA. Should Western United Domains fail to cure this breach within 15 working days, ICANN may commence the termination process as set forth in Section 5.3.4 of the RAA.

Failure to Escrow gTLD Registration Data

Section 3.6 of the RAA requires Western United Domains to, "on a schedule, under the terms, and in the format specified by ICANN" to "submit an electronic copy of the database described in Subsection 3.4.1 [of the RAA] to ICANN or, at its expense, to a reputable escrow agent mutually approved by Registrar and ICANN."

To date, Western United Domains has failed to comply with its obligation pursuant to Section 3.6 of the RAA by not escrowing data with Iron Mountain Intellectual Property Management, Inc ("Iron Mountain"), the ICANN approved escrow agent, or another reputable escrow agent approved by ICANN.

ICANN provided notice to Western United Domains concerning Western United Domains' obligation to escrow its gTLD registration in late 2007 and that Western United Domains should make plans to begin to escrow its gTLD registration data by 1 May 2008. More recently, ICANN reminded Western United Domains on 26 January 2010 of Western United Domains' obligation to begin to escrow gTLD registration data. This last communication

from ICANN contained a document explaining the data escrow specifications along with the data escrow agreement for review and processing. To date, Western United Domains has neither contacted ICANN nor Iron Mountain to sign the data escrow agreement and proceed escrowing gTLD registration data as required by Section 3.6 of the RAA.

As previously stated, ICANN may terminate the RAA before its expiration if a registrar fails to cure any breach of the agreement within 15 working days after ICANN gives the registrar notice of breach, pursuant to Section 5.3.4. Should Western United Domains fail to cure the breach cited herein by 6 May 2010, ICANN may commence the termination process.

ICANN specifically reserves the right to pursue any and all other breaches in addition to the breach mentioned above, and nothing herein shall be deemed a waiver of that right. Please contact me at (310) 301-3860 to commence discussions regarding Western United Domains' intentions.
