

## Response to Documentary Information Disclosure Policy Request

Thank you for your Request for Information dated 12 January 2014 (the “Request”), which was submitted through the Internet Corporation for Assigned Names and Numbers’ (ICANN) Documentary Information Disclosure Policy (DIDP) on behalf of The Centre for Internet & Society (CIS). For reference, a copy of your Request is attached to the email forwarding this Response.

### Items Requested

Your Request seeks the disclosure of the following information regarding the New gTLD Program auction:

- (i) How many gTLDs have been sold via the auction process, since its inception? (“Item No. 1”)
- (ii) What were the starting and winning bids in the ICANN auctions conducted? (“Item No. 2”)
- (iii) What revenue has ICANN received from the gTLD auctions, since the first ICANN auction was conducted? Please also provide information about the winner (name, corporate information provided to/ available with ICANN). (“Item No. 3”)
- (iv) How are proceeds from the gTLD auction process utilized? (“Item No. 4”)

### Response

ICANN’s DIDP is intended to “ensure that information contained in documents concerning ICANN's operational activities, and within ICANN's possession, custody, or control, is made available to the public unless there is a compelling reason for confidentiality.” (See <https://www.icann.org/resources/pages/didp-2012-02-25-en> (emphasis added).) As part of its approach to transparency and information disclosure, ICANN makes available on its website at [www.icann.org](http://www.icann.org) a comprehensive set of materials concerning ICANN’s operational activities as a matter of course, including, but not limited to, information about the New gTLD Program, which can be accessed through the New gTLD Program microsite at <http://newgtlds.icann.org/en/>.

The New gTLD Program microsite contains information about the Applicant Guidebook, current application status, evaluation panels, object and dispute resolution, delegated strings, contention set status, Trademark Clearinghouse, Post Delegation Dispute

Resolution, contracting, Community Priority Evaluation, and auctions. All information about the New gTLD Program auctions can be found at: <http://newgtlds.icann.org/en/applicants/auctions> (“Auctions Page”) or through links found on this page. Of particular relevance to your Request is the following information:

Notably, all of the information you seek in this Request No. 20150112-1 is publicly available on the Auctions Page.

With respect to Item No. 1, a list of all gTLDs that have been auctioned through the ICANN’s new gTLD auction process since its inception is available on the “Auctions Results Page” at <https://gtldresult.icann.org/application-result/applicationstatus/auctionresults>.

With respect to Item No. 2, the Auctions Results Page itself sets forth the details of each auction, including the string, the contention set, the date of the auction, the name of the winning applicant, the winning application ID number, and the winning price. (*See* <https://gtldresult.icann.org/application-result/applicationstatus/auctionresults>.) In addition, if you click on any of the winning prices listed on the Auctions Results Page, a link leads to the relevant auction report, which sets forth the details of the auction including the names of all the applicants that participated in the auction, the number of rounds in the auction, the starting and ending bid for each auction round, the number of eligible bidders for each auction round, and the aggregate demand for each auction round. (*See id.*)

With respect to Item No. 3, information responsive to this item can be found on the “Auction Proceeds Page” at <http://newgtlds.icann.org/en/applicants/auctions/proceeds> and the Auction Results Page at <https://gtldresult.icann.org/application-result/applicationstatus/auctionresults>. In particular, the Auction Proceeds Page sets forth a breakdown of the auction proceeds as of 30 January 2015. The net proceeds as of 30 January 2015 is \$32,756,392. As for the requested information about the auction winners, as noted above, that information is available on the Auction Results Page. The names of the winners are identified on this page and the winners’ application details can

be obtained by clicking the hyperlink for the winners' applicant ID numbers. (*See <https://gtdresult.icann.org/application-result/applicationstatus/auctionresults>.*)

With respect to Item No. 4, the responsive information is available on the Auctions Proceeds Page at <http://newgtlds.icann.org/en/applicants/auctions/proceeds>. As noted on the Auction Proceeds Page, “[auction] proceeds will be reserved and earmarked until the Board determines a plan for the appropriate use of the funds through consultation with the community. Auction proceeds are net of any Auction costs. Auction costs may include initial set-up costs, auction management fees, and escrow fees.” (*See <http://newgtlds.icann.org/en/applicants/auctions/proceeds>.*) Thus far, the auction proceeds remain reserved, as the Board has not yet adopted a plan for use of the proceeds.
