Pursuant to Section 2 of Specification 5 of Registry Agreements between ICANN and CNNIC for the .xn--55qx5d and .xn--io0a7i gTLDs, signed November 15, 2013, "All two-character ASCII labels shall be withheld from registration or allocated to Registry Operator at the second level within the TLD." and "The Registry Operator may also propose the release of these reservations based on its implementation of measures to avoid confusion with the corresponding country codes, subject to approval by ICANN." CNNIC now request the release of all two-character ASCII labels that do not appear on the ISO 3166-1 alpha-2 list and for which there is no corresponding government or country-code operator. If ICANN approve this proposal, all these released two-character ASCII labels will be equitably provided to any potential registrants as other normal labels.\r\n

Such labels may not be activated in the DNS, and may not be released for registration to any person or entity other than Registry Operator, provided that such two-character label strings may be released to the extent that Registry Operator reaches agreement with the related government and country-code manager of the string as specified in the ISO 3166-1 alpha-2 standard. The Registry Operator may also propose the release of these reservations based on its implementation of measures to avoid confusion with the corresponding country codes, subject to approval by ICANN.
