

AMENDED JUDGMENT

On the 15th day of March, 2004, Plaintiff, C. Itoh Middle East (Bahrain) (hereinafter "C. Itoh"), by and through the real party in interest, National Union Fire Insurance Company of Pittsburgh, PA. (hereinafter "NUFI"), filed a foreign judgment in the above-captioned matter, together with an accompanying affidavit and proof of mailing of a Notice of Filing of Foreign Judgment to the defendants, The People's Republic of the Congo and the Congolese Redemption Fund.

Pursuant to 12 Okla Stat. §§ 721-722, and the Supreme Court of Oklahoma's opinion in *Drillevich Construction, Inc. v. Stock*, 1998 OK 39, ¶ 20, 958 P.2d 1277, 1281, the foreign judgment in favor of the plaintiff and against the defendants became a judgment of this state as of March 15, 2004, and shall be treated in the same manner as a judgment of the district court of any county of this state. Attachment and execution are permitted under the Foreign Sovereign Immunities Act, 28 U.S.C. § 1610(c), as a reasonable period of time has now elapsed following the

entry of the original foreign judgment and its subsequent registration as a Judgment of this state on March 15, 2004.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the defendants, The People's Republic of the Congo and the Congolese Redemption Fund, pay to the plaintiff C. Itoh, by and through the real party in interest, NUFI, the following amounts:


- (a) Eight hundred twenty seven million four hundred seventy five thousand five hundred yen (¥ 827,475,500), plus interest at the French statutory rate from August 1, 1990 to March 15, 2004, in the amount of ¥ 972,007,165.39, for a total of ¥ 1,799,482,665.39;
- (b) Two hundred thirty three million two hundred three thousand seven hundred thirteen yen (¥ 233,203,713), plus interest at the French statutory rate from August 1, 1990 to March 15, 2004, in the amount of ¥ 273,936,894.97, for a total of ¥ 507,140,607.97;
- (c) One hundred fifty thousand francs (f 150,000), plus interest at the French statutory rate from August 1, 1990 to March 15, 2004, in the amount of f 176,201.05, for a total of f 326,201.05;
- (d) Sixty six thousand dollars (\$66,000), plus interest at the French statutory rate from September 12, 1996 to March 15, 2004, in the amount of \$42,429.55, for a total of \$108,429.55.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that interest will continue to accrue on the aforementioned amounts from March 15, 2004 at the rate applicable to judgments of this state, which, for 2004, is 5.04 percent.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that, at the option of the defendants, the defendants may pay to the plaintiff the number of United States dollars which

will purchase the yen and francs then due and owing, together with the interest then due and owing, at a bank-offered spot rate at or near the close of business on the banking day next before the day of payment.

IT IS SO ORDERED this 15th day of June, 2004.
