Item 1b. Please levy upon the property according to the following description:

All property in which the judgment debtors (or their alter ego, the Societe Nationale des Petroles du Congo) have any interest, including without limitation the Internet domain name ".cg".

We believe that the levied-upon entities possess only intangible property in which the judgment debtor has an interest. For this reason, the levying officer should not expect to remove any property from the levied-upon entities although, of course, the levying officer should accept any property tendered.

Item 2. As you can see, the judgment is in three currencies – Japanese Yen ("YEN"), French Francs ("FRF"), and U.S. dollars. Judgment was entered on April 19, 2005. Interest is accruing at the following daily rate:

As of today, April 26, 2005, the current amount outstanding is:


