It looks forward to metrics from ICANN Org relating to the numbers of Fellows that have gone on to take active participation in the

multistakeholder process at and through ICANN. If candidates have not continued on to benefit the ICANN Community, they may have been selected from the wrong pool of candidates, e.g. candidates who will continue to participate in the ICANN Community after their participation as Fellows (excluding the participants that were already working for a contracted party or other then-current community member when they benefited from the fellowship).

ICANN should implement certain KPIs to this program so that its costs and benefits can be more transparent. With this information, adjustments could be made to the outreach actions and targets.
