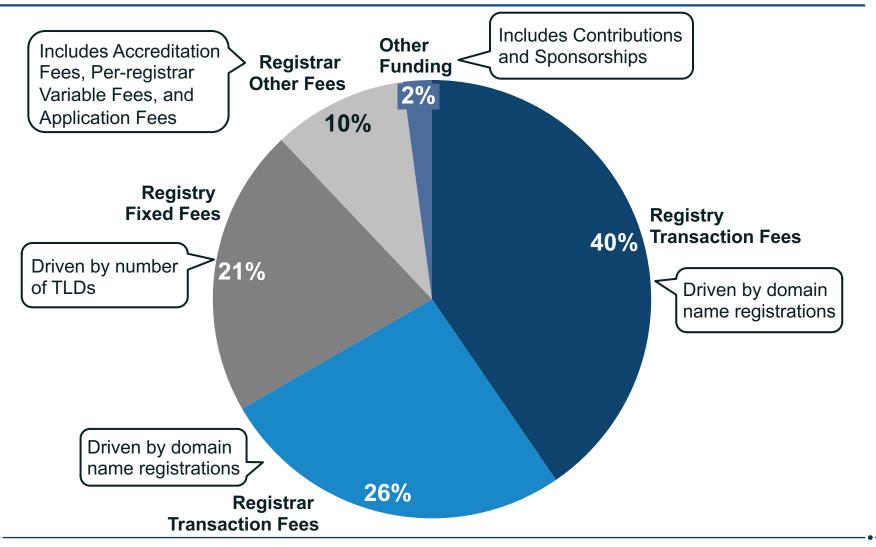

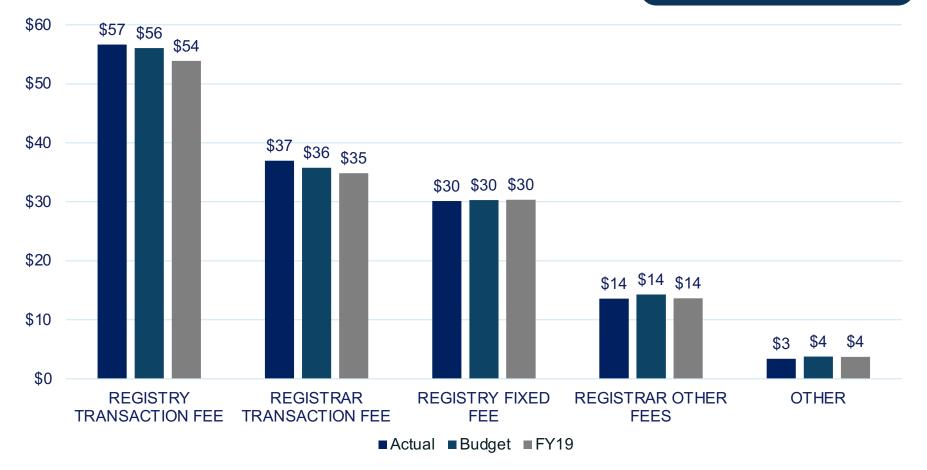




#### FY20 (Jul 19 – Jun 20) Funding vs Budget & FY19

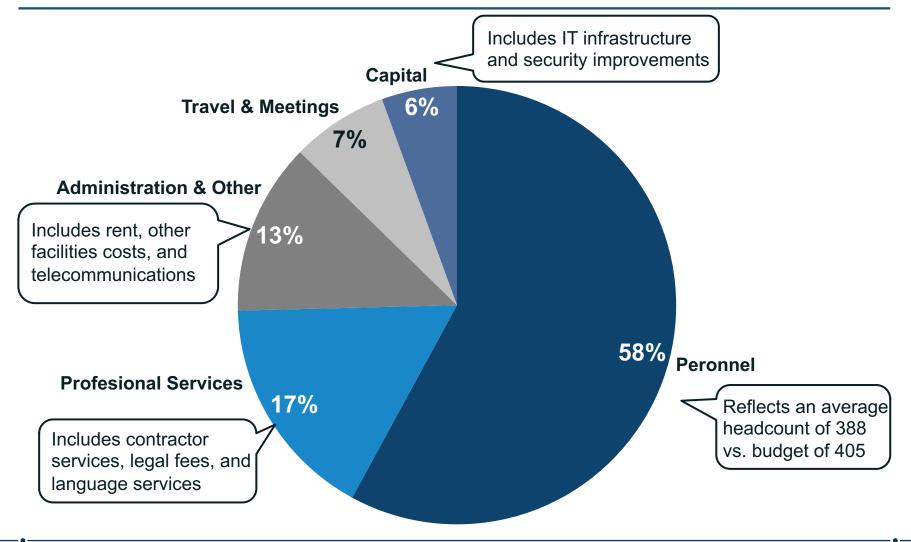




### FY20 (Jul 19 – Jun 20) Expenses by Cost Category

#### FY20 Expenses- \$126M



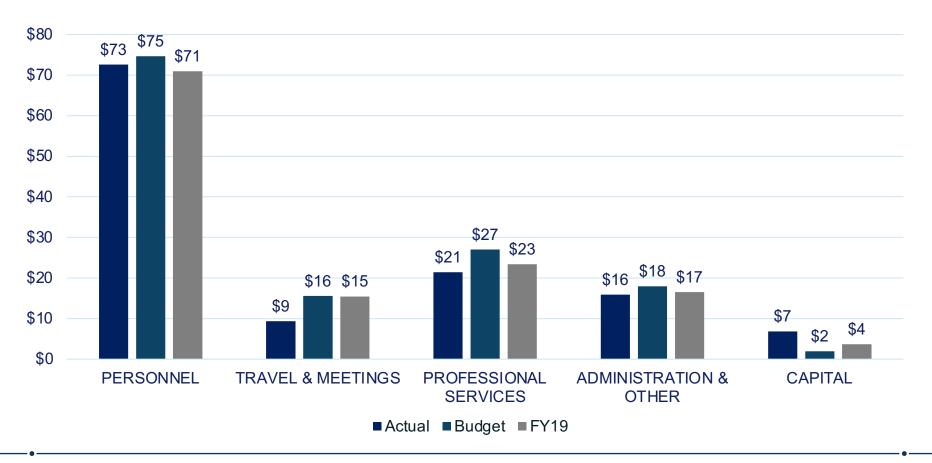


#### FY20 (Jul 19 – Jun 20) Operating & Capital Expense

 Meetings savings due to travel restrictions from the COVID-19 pandemic

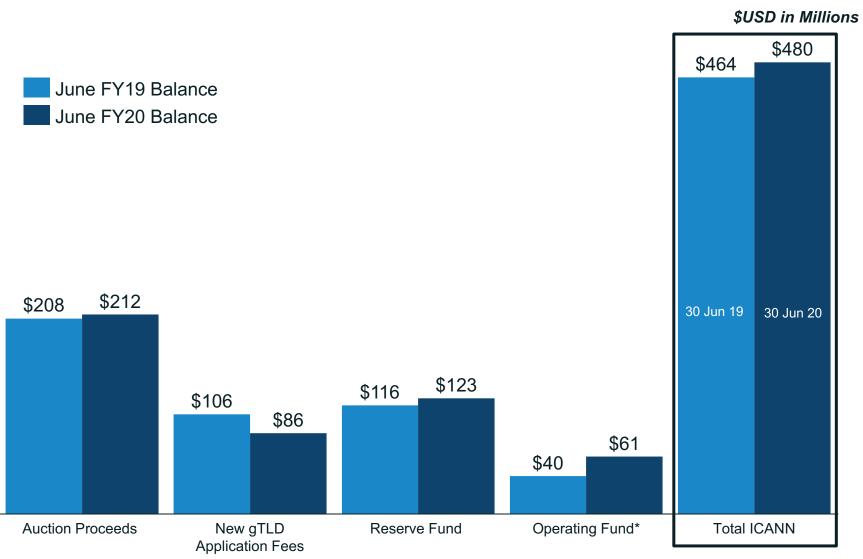

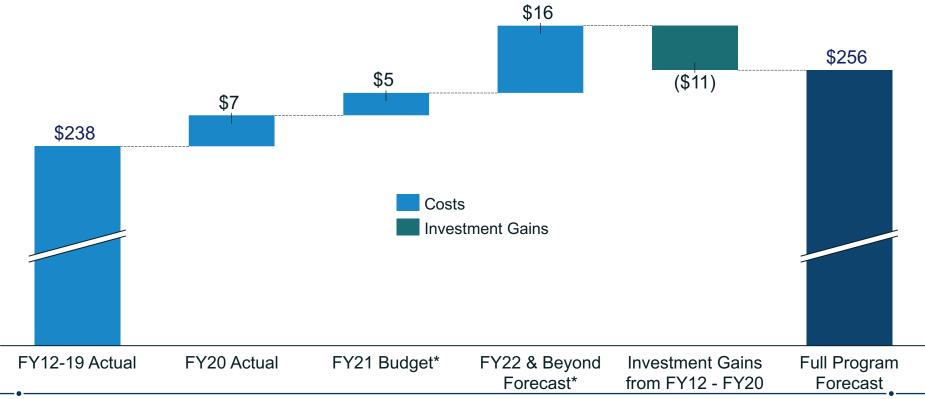

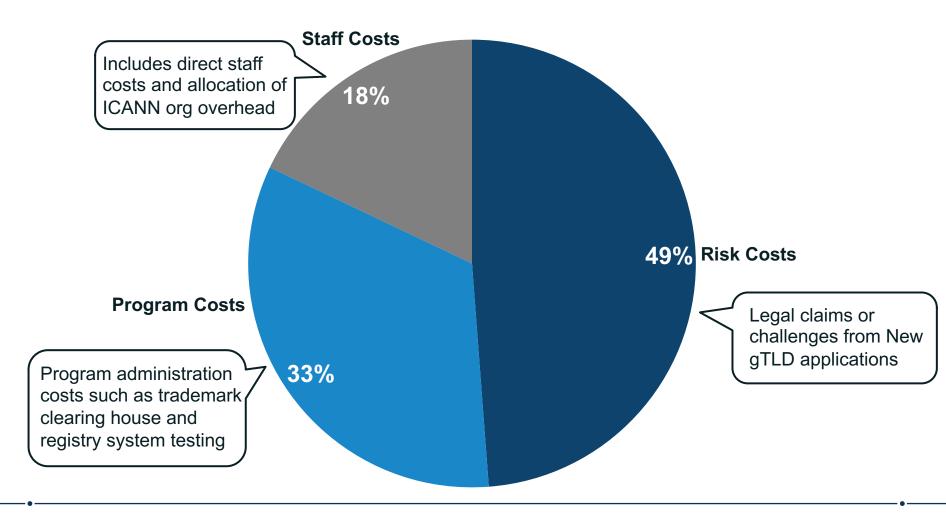




### FY20 (Jul 19 – Jun 20) New gTLD Expenses
