Due to COVID-19 travel restrictions, six Board meetings which were planned to be face-to-face were held virtually and, as such, there were no travel or travel-related expense reimbursements paid directly to Board members for these Board meetings. These virtual meetings were held around the three ICANN Public Meetings (October 2020, March 2021, and June 2021) and three Board workshops (September 2020, January 2021, and May 2021). After approval, payments were made on behalf of Board members for other virtual meetings, trainings, and subscriptions.

Göran Marby serves as President and CEO and is a member of the Board. Pursuant to his employment agreement, in FY21 Mr. Marby was paid \$707,135 in salary, and \$210,878 for at-risk pay, along with \$10,824 in reimbursement of expenses, and \$26,609 in payments were made on his behalf.

⁽²⁾ Manal Ismail is the Governmental Advisory Committee (GAC) liaison to the Board. The GAC liaison is not eligible for compensation.

The Chair of the Board is entitled (but not required) to receive compensation of \$75,000 annually, and other Board members (except the GAC liaison) are entitled (but not required) to receive compensation of \$45,000 annually. Upon request, compensation has been made to a legal entity owned by the Board member whose compensation therefore may not appear on ICANN's Form 990 (Part VII, Section A).
