## FY23 Annual Report of Expense Reimbursement and Other Payments to ICANN Directors for the Period 1 July 2022 Through 30 June 2023

This report is presented annually in accordance with Article 22, Section 3 of the ICANN Bylaws which provides, in part, that "The Board shall publish, at least annually...a description of any payments made by ICANN to Directors (including reimbursements of expenses)."

The table below represents reimbursements and compensation paid directly to Board members, as well as total payments made to third-party vendors such as hotels, restaurants, and travel agencies on behalf of Board members. Members are sorted alphabetically by first name. All figures are in USD and rounded to the nearest dollar.

FY23 includes the resumption of regular travel resulting in higher costs than recent years which were impacted by the COVID-19 pandemic. During FY23, there were five face-to-face meetings for Board members, including three ICANN Public Meetings (Kuala Lampur/September 2022, Cancún/March 2023, and Washington D.C./June 2023), and two Board workshops (Los Angeles/January 2023 and Brussels/April 2023). After approval, payments were made on behalf of Board members for other meetings, trainings, and subscriptions.

Göran Marby served as President and CEO and was a member of the Board until 21 December 2022. Pursuant to his employment agreement, in FY23 Mr. Marby was paid \$477,719 in salary, and \$112,166 for at-risk pay, along with \$46,790 in reimbursement of expenses, and \$74,232 in payments were made on his behalf.

Sally Costerton serves as Interim President and CEO and as a member of the Board beginning 21 December 2022. Pursuant to her employment agreement as interim President and CEO, in FY23 Ms. Costerton was paid \$357,073 in salary, and \$149,808 for at-risk pay, along with \$79,923 in reimbursement of expenses, and \$34,138 in payments were made on her behalf.

The Chair of the Board is entitled (but not required) to receive compensation of \$75,000 or its equivalent annually, and other Board members (except the GAC liaison) are entitled (but not required) to receive compensation of \$45,000 or its equivalent annually. Upon request, compensation has been made to a legal entity owned by the Board member whose compensation therefore may not appear on ICANN's Form 990 (Part VII, Section A).
