### China Hosts 2<sup>nd</sup> World Internet Conference

The 2<sup>nd</sup> World Internet Conference themed "An Interconnected World Shared and Governed by All" was held in Wuzhen, China

from 16 - 18 December. A team comprising board members and staff from ICANN attended the event, which was hosted by the Cyberspace Administration of China.

Fadi Chehadé, President and CEO of ICANN was invited to be a panelist at the Cyberspace Governance sub-forum and also delivered a speech at the closing ceremony of the conference. He spoke about ICANN's globalization plan, IANA Stewardship Transition and the role of ICANN in maintaining a global Internet. The conference drew over 2,000 representatives from over 120 countries.

## Clarifying Compliance Audit Program with APAC Contracted Parties

Following enquiries on the Compliance audit program, the Contractual Compliance team conducted several audit webinars on 30 November 2015. The webinars were targeted at APAC registries and registrars.

Approximately 80 participants from the region attended the webinars, with attendees from countries like Australia, China

and Vietnam. It was an opportunity for the contracted parties to learn more about the compliance audit program, address common audit questions and learn about the structure of the audit report. On 1 and 2 December 2015, APAC contracted parties also took the opportunity to have meetings with the audit team on a one-on-one basis, to ask more detailed questions regarding the audit program and processes. ## RSSAC Publishes Advisory on Service Expectations of Root Server Operators

In **RSSAC001: Service Expectations of Root Servers**, the RSSAC defines a set of service expectations that root server operators must satisfy. RSSAC001 was published concurrently with **RFC7720**, which specifies DNS root name service protocol and deployment requirements.

### Label Generation Ruleset for the Root Zone Version 1 (LGR-1)

The Integration Panel (IP) successfully evaluated the finalized Proposal for Arabic script Root Zone Label Generation Rules (LGR) submitted by the Arabic Script Generation Panel (GP), following the release of the proposal for public comments. The IP has integrated this proposal by the Arabic script GP into the first version of the Root Zone LGR. As per the Procedure to Develop and Maintain the Label Generation Rules for the Root Zone in Respect of IDNA Labels, LGR-1 is being released for public comments before finalization.

### Continuous Data-Driven Analysis of Root Server System Stability (CDAR) Study Plan

This study has been commissioned to examine the technical impact of the New gTLD Program on the root server system. As the first step, The Netherlands Organization for Applied Scientific Research (TNO) and its partners SIDN and NLnet Labs will publish the draft study plan for public comment. Feedback from the larger DNS community is critical to ensure a comprehensive approach to data gathering and analysis. Comments may be incorporated into the final study design.
