Roundtable on IPv6 Takes Place in Israel

A roundtable meeting on the status of Internet Protocol version 6 (IPv6) deployment in Israel was held in Tel-Aviv on 17 July. During the meeting, the Israeli Ministry of Communication Director-General, Brigadir-General (ret.) Nati Cohen, stated that



the Ministry will take the lead on Israel's transition to IPv6.

In addition, Jean-Jacques Sahel, ICANN Vice President of Stakeholder Engagement and Managing Director of Europe, and Ingrid Wijte, Registration Services Assistant Manager at the RIPE NCC, presented the global policy aspects of IPv6 transition.

Hebrew Label Generation Panel is Launched Successfully

During the past decade, the ICANN organization and community have made significant progress in their work towards a global, multilingual Internet. As part of this work, ICANN instituted the **IDN Program** to assist in the development and promotion of a multilingual Internet using Internationalized Domain Names (IDNs). A total of 151 IDN top-level domains (TLDs) have been delegated so far, including 95 IDN generic top-level domains (gTLDs) and 56 IDN country code top-level domains (ccTLDs).

The IDN Program is continuing to grow with the launch of the Hebrew Script Generation Panel in July. The panel will shape the rules governing the usage of the Hebrew characters in the Domain Name System (DNS) TLD. The panel members are from the Israeli Internet Community: Doron Shikmoni, Matitiahu Allouche, Meir Krausher, Dorit Lerrer, and Yoram Hacohen.

Yoram Hacohen, CEO of **ISOC-IL**, remarked on the launch of the Panel, stating "The Israeli Internet Association ISOC-IL is happy to lead the process and help the Israeli Internet Community and ICANN design proper rules for the implementation of Hebrew characters in the TLD."



EASTERN EUROPE & CENTRAL ASIA

ICANN Participates in the First International Cybersecurity Congress

From 5-6 July 2018, cybersecurity professionals from around the world convened in Moscow, Russia for the first **International Cybersecurity Congress (ICC)**. The event was hosted by Sberbank, the biggest state-owned bank in Russia, and its subsidiary BI.ZONE, a threat intelligence firm. Among the participants were CEOs and CISOs of global security players such as Interpol, SWIFT, SecureKey, AnchorFree, Kaspersky Lab, as well as local government representatives. Discussion topics ranged from the challenges of digital transformation to international cooperation. Russian President Vladimir Putin delivered a keynote about the state plans for the development of the Russian digital economy.



ICANN's Alexandra Kulikova, Global Stakeholder Engagement Director - Eastern Europe and Central Asia, and John Crain, Chief SSR Officer, were part of a group of experts invited to witness a real-time simulation of a cyber incident response, in which members of Sberbank's cybersecurity team mitigated an attack. Crain was also a panelist in a session on international cooperation to address cybercrime, where he highlighted the need for national police to modernize and spoke about the ICANN Office of the Chief Technology Officer (OCTO) team's capacity building efforts to prepare law enforcement for global cyber challenges.

POLICY UPDATE

Study Group on the Use of Emoji as Second-Level Domains Begins Work

Following an [ICANN Board Resolution](#), the study group was established by the Country Code Names Supporting Organization (ccNSO) Council to provide the country code top-level domain (ccTLD) community and the Council with:

- A comprehensive overview of the issues associated with the use of emoji as second-level domains.
- Current practices by ccTLD managers who allow emojis as second-level domains.

Although the terms of reference were adopted in February 2016, the study group started its work following ICANN62. Further details about the background and scope of activities of the study group can be found [here](#).

The study group has participants from diverse backgrounds and is made up of members from the broader ccTLD community, the Security and Stability Advisory Committee (SSAC) - who will participate in an individual capacity, and ICANN staff from the Office of the Chief Technology Officer.

The study group is expected to present its findings to the broader ccTLD community and ccNSO Council by ICANN64.



GNSO Council Launches EPDP on the Temporary Specification for gTLD Registration Data

On 19 July 2018, the Generic Names Supporting Organization (GNSO) Council commenced the GNSO's first Expedited Policy Development Process (EPDP): the EPDP on the Temporary Specification for gTLD Registration Data. The EPDP must be completed within 12 months of the implementation effective date

of the Temporary Specification (25 May 2018), which was an interim measure to bring existing WHOIS obligations in line with the European Union's General Data Protection Regulation (GDPR) requirements. The Council [voted](#) to pass the EPDP [Initiation Request](#) and then adopted the EPDP Team [Charter](#). The Council also appointed Kurt Pritz as the Chair of the EPDP team, following a unanimous recommendation from the selection panel. While the EPDP team has limited membership composition, the wider ICANN community can closely follow its deliberations and provide input through various channels. IGO-INGO Access to Curative Rights Protection Mechanisms PDP Submits Final Report to GNSO Council

On 9 July 2018, the International Governmental Organization and International Non-Governmental Organization (IGO-INGO) Access to Curative Rights Protection Mechanisms Policy Development Process (PDP) Working Group submitted its [Final Report](#) to the GNSO Council. The Final Report contains five consensus recommendations. Since October 2012, the Governmental Advisory Committee (GAC) has issued advice on the topic of IGO identifier protections. Several inconsistencies between the GAC advice and PDP consensus recommendations have yet to be reconciled, including on the topic of appropriate protections for IGO acronyms. The Council [determined](#) to review the PDP Final Report with a view toward facilitating the resolution of the outstanding inconsistencies between existing GAC Advice and prior GNSO policy recommendations on the overall scope of IGO protections. In the meantime, the Council informed the ICANN Board and the GAC that the PDP Working Group has completed its work.

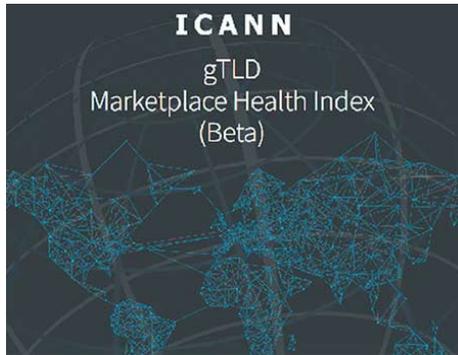

Expanding IDNs in South Asian Scripts

On 10 July, the Neo-Brahmi Generation Panel (NBGP) held a well-attended meeting in Dhaka, Bangladesh in collaboration with the Bangla Academy (the relevant government-run language organization) to discuss the current draft of the Proposal for Bengali Script Root Zone LGR with local stakeholders. This event was the last in a series of workshops and meetings organized by NBGP in Bangladesh, India, Nepal, and Sri-Lanka to finalize the work on relevant Root Zone Label Generation Rules for Bengali, Devanagari, Gujarati, Gurmukhi, Kannada, Malayalam, Oriya, Tamil, and Telugu scripts.
