During ICANN68, the GNSO Council approved a motion requesting that the ICANN org prepare a Preliminary Issue Report on the issues identified in the **Transfer Policy Initial Scoping Paper**. This report is expected to assist the GNSO Council in determining whether one policy development process (PDP) or a series of PDPs should be initiated on changes to the Transfer Policy.

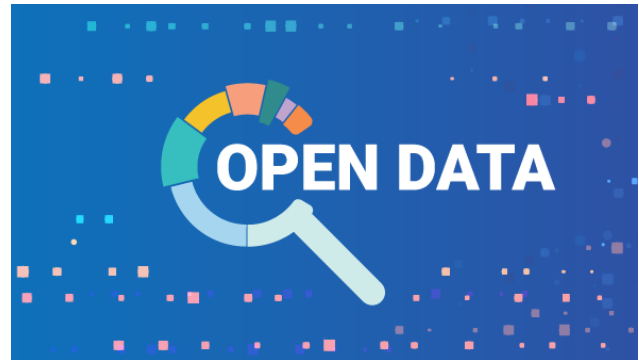

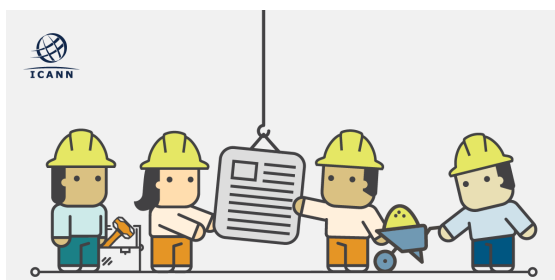

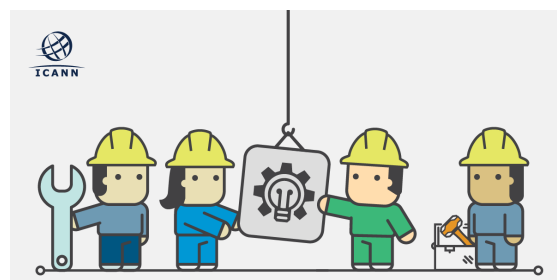
