## EDITORIAL

Panama is in the news, not only because of our beaches, the Panama Canal, or our first participation in the World Cup. Later this month, one of the biggest global Internet events comes to Panama. The ICANN62 Policy Forum comes after two important events also held in Panama City: the regional preparatory meeting for the Internet Governance Forum (LACIGF 10) and the annual meeting of the Latin American and Caribbean Internet Addresses Registry (LACNIC 29). These activities are positioning our country as a significant meeting place for the multistakeholder Internet community.

Just before ICANN62, on 21 and 22 June, we will meet with leaders in the Central American and Panamanian Internet ecosystem at the 2018 edition of the Mexico/Central America LAC-i-Roadshow, a project of the [Latin America and the Caribbean Strategy](#). ### GAC Updates

The Governmental Advisory Committee (GAC) chair welcomed the country of Ecuador as a committee member. The GAC now comprises 177 member countries and territories and 36 observer

organizations.

Recently, the GAC has conducted meetings and exchanged **correspondence** with the ICANN Board on many timely topics, including:

- Implementation of the General Data Protection Regulation (GDPR) enacted by the European Union.
- ICANN consideration of the .persiangulf new generic top-level domain.
- Clarification of protections of intergovernmental organization names and acronyms at the second-level.

At ICANN62, the GAC will:

- Conclude its one-year capacity-building workshop pilot with a full-day workshop on Sunday, 24 June. For more information, contact [gac-staff@icann.org](mailto:gac-staff@icann.org).
- Focus considerable session time to GDPR implementation matters - meeting internally and exploring issues with the ICANN Board and the GNSO Council.
- Finalize arrangements for the High-Level Governmental Meeting scheduled for 22 October 2018 during ICANN63.

## IDN Implementation Guidelines

### Final Proposed Draft of Internationalized Domain Name (IDN) Implementation Guidelines Released

On 10 May, the ICANN org released the **final proposed draft** of the Guidelines for the Implementation of the Guidelines for the Implementation of Internationalized Domain Names Version 4. The document provides guidelines on IDN registration policies and practices designed to minimize the risk of cybersquatting and consumer confusion. This draft is currently pending ratification from the ICANN Board of Directors.

## ICANN Announces DENIC eG as a New ICANN-Designated Agent to Support Registrar Data Escrow Services

On 15 May, the ICANN organization entered into an agreement with DENIC eG, the German-based nonprofit operator of the country code top-level domain .de, as an ICANN-designated agent to support Registrar Data Escrow (RDE) services on its behalf. The RDE program is intended to protect registrants in the event of registrar failure or termination of a Registrar Accreditation Agreement.
