Governance Primer comes to the Rio de la Plata

"The Governance Primer is a youth-led, free and open Internet governance course that seeks to explain the subject to anybody who is interested in it, regardless of their background - be they undergraduate teenagers or electrical engineer grandparents," says Mark Datysgeld, Founder of the Governance Primer.

The Governance Primer is the creation of ICANN NextGenner Mark Datysgeld, developed with other young leaders of ICANN's NextGen and Fellowship programs. After two successful courses in São Paulo, Brazil, at the Pontifical Catholic University of São Paulo (PUC-SP), the course was taken to Buenos Aires, Argentina, at the University Torcuato Di Tella, and to Montevideo, Uruguay, at the ObservaTIC (University of the Republic) this October. ICANN sponsored all of the courses.

The Brazilian experience was a success, with over 60 participants - and feedback showed that the course was on the right track. The next course in Buenos Aires also had impressive numbers in every measurable category. On the other hand, the Montevideo course was aimed at a smaller audience of up to 30 people - allowing a more interactive experience with open discussions and role play.

The Governance Primer is in the region to stay. We hope to see more courses next year!

First Entrepreneurship and Internet Center Opens in Latin America

The opening of the first Center for Entrepreneurship and Internet in Latin America and the Caribbean (CELLAC) was launched in

the city of Asunción, Paraguay on 12 October. This is the second center worldwide, the first one being in Egypt. This opening is a joint initiative of ICANN, SENATICs and LACTLD.

The inaugural event took place at the local headquarters of SENATICs, where the center is located. It began with speeches by Sally Costerton, ICANN's Senior Advisor to the President and Senior Vice President, Global Stakeholder Engagement; Andrés Piazza, LACTLD General Manager; and Minister David Ocampos, Nicolas Caballero and Leticia Romero from SENATICs.

"We are confident that CEI LAC represents an important milestone for Latin America and the Caribbean, and will bring new opportunities to strengthen the sector," said Rodrigo de la Parra, ICANN's VP for LAC, speaking to journalists.

After the inauguration ceremony, the first training course on the Domain Name System (DNS) - called "DNS Industry - Business, Marketing, Operations and Legal Aspects" - was conducted by Michele Neylon from Blacknight Solution and Leon Sanchez from Fulton & Fulton SC. The course attracted 25 trainees from 10 LAC countries.

LAC-i-Roadshow Caribbean 2016

The Caribbean Network Operators Group (<u>CaribNOG</u>) and ICANN hosted CaribNOG12 and the 2016 Caribbean edition of the LAC-i-Roadshow* in Philipsburg, Sint Maarten from 24 to 26 October. CaribNOG joined with LACNIC, the Internet Society, and Bureau Telecommunications and Post Sint Maarten for "Internet Week Sint Maarten." The week started with CaribNOG 12 and the LAC-i Roadshow, and was followed by <u>"Sint Maarten On The Move"</u> from 27 to 28 October 2016.

The three events jointly targeted senior policymakers and government officials, regulators, IT professionals, university students, and technology journalists and bloggers. The range of topics included cloud computing, content delivery and peering, management of Internet Protocol (IP) networks, Internet Protocol Version 6 (IPv6), DNS Security Extensions (DNSSEC), Internet Exchange Points, Resource Public Key Infrastructure (RPKI) and cybersecurity.

* The LAC-i-Roadshow is part of the LAC Strategy, which was developed by the different stakeholder groups from the Latin America and Caribbean region represented at ICANN. Its goal is to raise awareness across the region on key topics related to the DNS critical infrastructure.



POLICY UPDATE

Governmental Advisory Committee ICANN57 Communiqué

The Governmental Advisory Committee (GAC) Communiqué from ICANN57 is available for review here. ICANN receives input from governments through the GAC. Its key role is to give advice to ICANN on issues of public policy, especially where there may be an interaction between ICANN activities or policies and national laws or international agreements. The GAC meets three times a year at ICANN Public Meetings, where it discusses issues with the ICANN Board of Directors and other ICANN Supporting Organizations, Advisory Committees and other groups.

GNSO Council Approves Proposed Framework for Future Cross-Community Working Groups

Up to now, cross-community working groups (CCWGs) have been formed on an ad-hoc basis, without a consistent framework of underlying operating principles that take into account the different working methods of the various Supporting Organizations and Advisory Committees. In March 2014, the Country Code Names Supporting Organization (ccNSO) Council and Generic Names Supporting Organization (GNSO) Council approved the charter for a CCWG to develop a framework for future CCWGs. The proposed framework identifies key principles and process steps to be considered during each phase of the CCWG life cycle (initiation, formation, operation, decision-making, closure, and post-closure). The CCWG submitted its proposed framework to the ccNSO and GNSO Councils on 19 September 2016. The GNSO Council approved the proposed framework at its meeting on 13 October 2016.

Extended Process Review Panel Working Group (EPSRP) - Final Report

In June 2015 the ICANN Board of Directors requested that the Country Code Names Supporting Organization (ccNSO) - in consultation with other stakeholders, including the Governmental Advisory Committee (GAC) and the Security and Stability Advisory Committee (SSAC) - provide further guidance on and refinement of the methodology for the second string similarity review process. This includes the interpretation of split recommendations, to be applied to the relevant, current and subsequent cases in the Internationalized Domain Names (IDN) Country Code Top-Level Domains (ccTLD) Fast Track process, as well as to inform the proposed policy for the selection of the IDN ccTLD strings. In October 2015, the ccNSO established a working group with participants from the ccTLD community and the GAC.

In July 2016, the **EPSRP working group** sought feedback, via a **public comment proceeding**, on its proposed guidelines for the methodology on the second string similarity review process, including the interpretation of a split recommendation. Feedback received during the public comment proceeding included a **statement from the At-Large Advisory Committee**, **input from Verisign** and a **statement from the SSAC**. The GAC submitted **comments** at a later stage. The ccNSO **discussed** the EPSRP **final report** at its meeting at ICANN57.

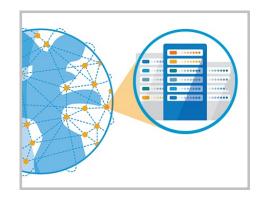
Key Signing Key Rollover Operations Begin

On 27 October 2016, ICANN created a new root zone key signing key (KSK). This new cryptographic public/private key pair was made during the quarterly Root KSK Ceremony at our secure key management facility in Culpeper, Virginia. With this key generation, the initial operational phase of the first root KSK rollover - the process of changing the "master key" of the Domain Name System (DNS) - has begun. Network operators, Internet service providers and those who have enabled DNS Security Extensions (DNSSEC) validation will need to update their systems with the new root KSK once it has been published in July 2017. Available for Comment - New gTLD Program Study Results

Reviews of the New gTLD Program are currently underway to assess whether program objectives are being met. In October, ICANN published two new reports that will feed into these reviews:

"Phase II Assessment of the Competitive Effects
 Associated with the New gTLD Program" explores
 whether the program has affected competition in the
 domain name marketplace. Read the draft report or
 submit a comment.



"Continuous Data-Driven Analysis of Root Server System Stability" will help the Internet community
determine if additional steps are required to safeguard the root zone's security and stability. <u>Read</u>
the draft report or <u>submit a comment</u>.

Internationalized Domain Names: Developing Root Zone Label Generation Rules

In October, the Lao script community finalized its proposal for root zone Label Generation Rules (LGR). The proposal is the fifth to be finalized - after Arabic, Armenian, Georgian and Khmer script



rules - and is now available for <u>public comment</u>. In addition, ICANN announced the formation of a Generation Panel to develop LGRs for the Greek script.

Root zone LGRs determine valid <u>Internationalized Domain</u> <u>Name</u> (IDN) labels and their variants in the world's many languages and scripts. Internationalized Domain Names include non-ASCII characters from scripts such as Arabic.
