*TICAL 2006 was held in Buenos Aires, Argentina, 13-15 September 2016.*

The Latin American and Caribbean Network Operators Group (LACNOG) is a community of people who operate Internet networks in the region and exchange experiences through the mailing list [lacnog@lacnog.org](mailto:lacnog@lacnog.org). Once a year, our main meeting is held to strengthen ties between operators and to share updates on technology and network operation issues. Since September, LACNOG has begun to co-organize meetings with other communities in the region. Our first experience was working with RedClara, the organizer of **TICAL 2016**, a conference for Directors of Information and Communications Technologies (ICT) from Latin American universities.

There is often a misconception that "network operator" is synonymous with "Internet service provider." In fact, universities are network operators with significant experience in managing campus networks and in implementing new technologies. To involve more universities and academia in LACNOG, during the TICAL Conference held in Buenos Aires, we developed a workshop for network operators from universities.

The meeting exceeded the organizers' expectations and was a valuable experience for both communities. The lessons learned and interactions among universities will result in greater local collaboration, more efficient Internet services in their cities, and a larger and improved LACNOG community.

On 1 October 2016, the contract between ICANN and the United States Department of Commerce National Telecommunications and Information Administration (NTIA), to perform the Internet Assigned Numbers Authority (IANA) functions, **officially expired**. This historic moment marks the transition of the coordination and management of the Internet's unique identifiers to the private sector, a process that has been committed to and underway since 1998.

## Fire on Cargo Ship Affects IT Equipment Bound for ICANN57 Hyderabad

ICANN Meetings are a large-scale technical event. The visible portions like microphones, monitors and cameras are the tip of an iceberg. Beneath the surface, there miles of cable and hundreds of pieces of equipment providing connectivity, and enabling engagement and the seamless presentation of ICANN sessions.

Unfortunately, some of our equipment was recently impacted by a fire.

### What Happened?

On 1 September 2016, an explosion caused a fire on a cargo ship docked in Hamburg, Germany. Our Public Meeting technical equipment was on board. We had two containers - a 40-foot and a 20-foot container.

It took 150 firefighters four days to extinguish the fire. The ship crew initially tried to extinguish the fire and sustained slight injuries. No one else was hurt. Reports indicated that welding in the cargo hold caused the accident.

The ship had departed Helsinki, Finland, after ICANN56 and the equipment was bound for Hyderabad, India via Mumbai. [Read more...](#)

## LAC ACTIVITIES & HIGHLIGHTS

### ICANN Visits Brazil to Discuss Internet Dispute Resolution

On 14 September, the regional ICANN team participated in a panel called "Dispute Resolution in the Internet," promoted by the Brazil-Canada Chamber of Commerce (CCBC) and the CCBC Arbitration and Mediation Center (CAM).

Dr. Esther Nunes, President of CCBC, and Vanda Scartezini, member of CAM, opened the event. Dr. Paulo Perrotti, partner at Perrotti and Barrueco, presented the process and jurisprudence of domain name resolutions, mentioning the Brazilian system for dealing with disputes at the country code top-level domain (ccTLD) level. Dr. Rodrigo Azevedo from Silveiro Advogados discussed the international framework, including Uniform Rapid Suspension (URS) and Uniform Domain Name Dispute Resolution Policy (UDRP) processes and their interactions with arbitration centers around the world.

Daniel Fink, ICANN's Senior Manager of Stakeholder Engagement for Brazil, explained ICANN's role in policy making, described the new landscape of domain names with the new generic top-level domains (gTLDs), and showed results from ICANN's Domain Name Health Index. The audience was interested in the scope of indicators included in the Health Index, especially the updates on decisions against registrants through the URS and UDRP processes.

Lively discussions followed, with questions about:

- Processes related to the upcoming policy development process (PDP) for a possible new round of gTLDs
- Repercussions of the IANA stewardship transition for the Internet governance landscape
- Importance of brand protection with the expansion of domain choices in the Domain Name System (DNS) marketplace

### A Busy ICT Week in Barbados

Several events related to information and communications technologies took place during ICT Week in Barbados, held from 19 to 23 September.

On 20 September, the 19th General Conference of Caribbean Ministers and 33rd Executive Council meetings took place under the theme "Conquering Resource Constraints and Enhancing Effectiveness through Collaboration." From 21 to 22 September, the 14th Caribbean Ministerial Strategic ICT Seminar was held under the same theme.

ICANN received a special invitation from the Caribbean Community Secretariat (CARICOM) to attend the 56th Special Meeting of the Council for Trade and Economic Development (COTED), which took place on the afternoon of 21 September.

There was also one offsite event titled "InterCommunity 2016." The event aimed to tap the power of the global Internet to bring members together for conversations on the issues they all care deeply about. Topics included connecting the unconnected and increasing trust in the Internet, a topic ICANN spoke about in the session "Increasing Trust in the DNS System." ICANN also updated the audience on the IANA stewardship transition.

Barbados is a member of ICANN's Governmental Advisory Committee (GAC) and County Code Names Supporting Organization (ccNSO). There are currently three At-Large Structures in Barbados operating under the Latin American and Caribbean Islands Regional At-Large Organization (LACRALO). A number of ICANN fellows and stakeholders from Barbados participate in ICANN working groups.

## LACNIC 26/LACNOG 2016

The annual meeting of the Latin American and Caribbean Internet Addresses Registry (LACNIC) took place in San Jose, Costa Rica, from 26 to 30 September. As usual, the meeting was held in conjunction with the annual conference of LACNOG. The general program consisted of one day of training workshops on new technologies, security and Internet Protocol version 6 (IPv6) deployment; and four days of lectures and panel discussions on current issues and keynote presentations by leading international experts.

ICANN had a strong presence throughout the week with diverse presentations and an information booth that distributed publications. ICANN staff gave four presentations:

- **Carlos Alvarez** - responding to online threats
- **Andres Pavez** - key signing key (KSK) rollover
- **Elise Gerich** - update on IANA stewardship transition
- **Alain Durand** - IPv6 deployment and GDP

The LACNIC event closed with a special wrap-up session about the IANA functions stewardship transition, which included a video featuring several members of the Internet community who were involved in the process.

### POLICY UPDATE

## RSSAC Issues Statement on the Unavailability of a Single Root Server

In its recent [statement](#), the Root Server System Advisory Committee (RSSAC) reviewed information on current architectures, root server availability and short-term (hours or days) outages caused by administrative errors or attacks. Based on information available today, the RSSAC concluded that the loss of a single root server would not cause immediate stability issues for the root server system and the Internet that depends upon it.

## Comments on Guidelines for the Extended Process Similarity Review Panel

On 31 August 2016, the Security and Stability Advisory Committee (SSAC) published "[SAC084: SSAC Comments on Guidelines for the Extended Process Similarity Review Panel \(EPSRP\) for the Internationalized Domain Name \(IDN\) Country Code Top-Level Domain Fast Track Process\[r20.rs6.net\]](#)." This comment focuses specifically on the EPSRP and some very basic issues that have been exposed in a review of the proposed guidelines.

In June 2015 the ICANN Board of Directors had requested "*the ccNSO, in consultation with other stakeholders, including GAC and SSAC, to provide further guidance on and refinement of the methodology of second string similarity review process, including the interpretation of its split recommendations, to be applied to the relevant current and subsequent cases in the IDN ccTLD Fast Track process as well as to inform the proposed policy for the selection of the IDN ccTLD strings*". In October 2015, the ccNSO established a working group with participants from the ccTLD community and GAC. In July 2016, the [EPSRP working group\[ccnso.icann.org\]](#) sought feedback, via a [public comment proceeding\[icann.org\]](#), on its proposed guidelines for the methodology on the second string similarity review process, including the interpretation of split recommendation.

The inputs received within the public comment timeframe included: a statement from ALAC (<https://forum.icann.org/lists/comments-proposed-epsrp-guidelines-20jul16/msg00000.html>) [forum.icann.org], input from Verisign (<https://forum.icann.org/lists/comments-proposed-epsrp-guidelines-20jul16/msg00001.html>) [forum.icann.org], and SSAC (as per the SSAC comments mentioned above).

Comments from the GAC (<https://ccnso.icann.org/about/schneider-to-sataki-28sep16-en.pdf>) [[ccnso.icann.org](https://ccnso.icann.org)] were also submitted at a later stage.

The EPSRP finalized its report [[community.icann.org](https://community.icann.org)] and submitted it to the ccNSO Council for adoption at their meeting in Hyderabad. If adopted, the recommendations will be submitted to the Board.

## At-Large Publishes Briefing Paper on Policy Issues

In a collaborative effort between community members and ICANN Policy Development Support staff, At-Large has published "[At-Large Community Policy Issues - Why End Users Should Care](#)." The briefing paper provides an overview of 12 topics, ranging from accountability and transparency of ICANN to WHOIS and Registration Directory Services. The document also explains why each issue is relevant to end users, with the aim of helping more end users understand the work of At-Large and participate in ICANN. At-Large members have widely shared this briefing paper for outreach and capacity-building purposes.

## GNSO Council Approves Improvements

At its meeting on 1 September 2016, the Council of the Generic Names Supporting Organization (GNSO) voted to adopt [modifications to the GNSO Operating Procedures](#) relating to motions and elections of the chair and vice chair, as proposed by the GNSO Standing Committee on Improvements (SCI). With respect to motions, the SCI proposed a new section that records the informal processes that the GNSO currently uses. With respect to elections of the chair and vice chair, the SCI proposed minor modifications regarding eligibility, and a new section describing the procedures for four scenarios relating to the chair election and the selection of interim vice chairs. Following the completion of these two tasks, the GNSO Council subsequently instructed the SCI to disband.

## ALAC Reappoints Alan Greenberg as Chair

The At-Large Advisory Committee (ALAC) has reappointed current chair [Alan Greenberg](#) to another one-year term, beginning 9 November 2016. Following the call for nomination in August 2016, Greenberg was the sole candidate. Greenberg [accepted](#) the nomination, and therefore, the ALAC appointed him by acclamation.

Since 16 October 2014, Greenberg has been leading the ALAC to focus on several critical areas concerning the organizational effectiveness of the At-Large community. Examples include clarifying the accreditation criteria and participation expectations of At-Large Structures, mobilizing more At-Large members to get involved in policy development, and advancing the ALAC position within ICANN.

Notably, Greenberg has played a key role in leading ALAC involvement in the IANA stewardship transition and process to enhance ICANN accountability. These areas of work will remain ALAC priorities during Greenberg's next term.

## New Consolidated "Calls to Action" Page Launched

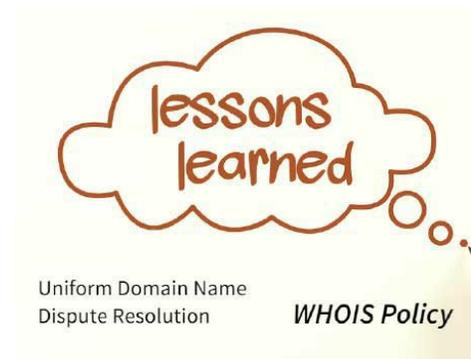
