Please, explain: what is the time of review? What has changed by now? What the website was not doing? And what means the same, the linked site doing?
5. Also, the domain has been listed with LegitScipt which also verifies domains under other jurisdictions aside from the US	5. The domain couldn't be listed with LegitScipt, which is endorsed by the NABP on behalf of the government agencies that license and regulate pharmacies and pharmacists in the United States, Canada, and other jurisdictions. Russian Federation does not refer to LegitScript as the "appropriate authority" to which rogue Internet pharmacies should be reported.

In the end of this letter we ask you once more to take into account our objections and comments. We hope that you will help us to determine the reactivation options available to us. Just imagine, how many efforts were made for registration procedures and how much money were invested in advertisement. # 9. What are you asking ICANN to do now?

This is to inform you that we asked the ICANN Contractual Compliance team to resolve dispute between us and the registrar GoDaddy concerning the domain transfer matter. We provided the ICANN Contractual Compliance team, by their request, with additional information and also submitted our mutual correspondence with the registrar concerning the dispute.

We hoped, that the ICANN Contractual Compliance team will arrange competent and impartial investigation of the whole matter. But in the final reply they declared, that the registrar has not breached its obligations under the Registrar Accreditation Agreement (RAA) or ICANN's Consensus Policies, referring on the statement, that the registrar may set their own domain use (or anti-abuse) policy and on the base of it suspend the Registered Name Holder's account. As a result of it the ICANN Contractual Compliance team has taken decision to close the matter.

We state, that our complaint was not considered properly. The final reply is formal and entirely repeats the statements of the registrar. It is quite evident, that the Contractual Compliance team has taken the registrar's side without thorough examination of our explanations and comments.

We are asking BGC to enforce the registrar to unlock our domain name and provide us with Autoinfo code in order to transfer to other registrar.

# 10. Please state specifically the grounds under which you have the standing and the right to assert this Request for Reconsideration, and the grounds or justifications that support your request.

The grounds for our standing and the right to assert this request are based on the following reasons:

1) The registrar refers on the Section 5 of GoDaddy's Universal Terms of Service, where the right to act as determined by GoDaddy in its sole and absolute discretion is declared. It means, that

GoDaddy can submit insubstantial accusations without any evidences. This is actually what happened in our case, when we were blamed in violation of the Ryan Haight Online Pharmacy Consumer Protection Act of 2008.

Even the sole and absolute discretion should have certain limuts.

We insist on the fact that, it is not International law and should not be undertaken by the whole world. Our company LLC"MP-Enterprises" is a legal entity registered in Russian Federation and complying all country's laws and instructions concerning the distance trade of pharmaceutical substances. We sale and distribute in Russian Federation Indian medication. All mentioned pharmacy is certified in Russian Federation and we have the State License for this activity.

2) The registrar states, that it "has worked tirelessly to help pass important legislation to combat the spread of illegal pharmacy sites that sell potentially dangerous medications without the proper prescriptions".

This statement is in no case concerned us. We confirm that our site is legal and we don't sell potentially dangerous medications. The registrar never submitted any substantial evidences, that this is not so. We would like to draw your attention to the fact, that the GoDaddy is selected by us to provide technical assistance in IT service. It is not supposed their staff to fulfill police operations to combat the spread of illegal pharmacy. For this purposes there are special entities worldwide, and in Russian Federation as well. More than that, the question is arisen, why the staff of internet company "has worked tirelessly to help pass important legislation" in pharmacy? It is clear, that this job was done by the order from pharmaceutical companies and certainly not free of charge. So this staff of GoDaddy is highly motivated to lobby interests of pharmaceutical companies wherever it is possible, including the withdrawing the companies like us from pharmacy markets. That is why registrar stubbornly not willing to listen to our objections and comments.

#### Terms and Conditions for Submission of Reconsideration Requests

The Board Governance Committee has the ability to consolidate the consideration of Reconsideration Requests if the issues stated within are sufficiently similar.

The Board Governance Committee may dismiss Reconsideration Requests that are querulous or vexatious.

Hearings are not required in the Reconsideration Process, however Requestors may request a hearing. The BGC retains the absolute discretion to determine whether a hearing is appropriate, and to call people before it for a hearing.

The BGC may take a decision on reconsideration of requests relating to staff action/inaction without reference to the full ICANN Board. Whether recommendations will issue to the ICANN Board is within the discretion of the BGC.

The ICANN Board of Director's decision on the BGC's reconsideration recommendation is final and not subject to a reconsideration request.
