### **Discussion Re: Reconsideration Request 17-3:**

Moving on to the next resolution, Chris.

CHRIS DISSPAIN: Thank you, Steve.

This one is a reconsideration request in respect to .GAY. We've already done the conflicts. So, Amy, you're back on again.

AMY STATHOS: Thank you, Chris.

This particular one relates to the requestor .GAY LLC. And in similar fashion to the one we previously discussed, it relates to a DIDP request relating to the CPE process review. CPE, again, is Community Priority Evaluation.

And the Board Accountability Mechanisms Committee, as it did previously, evaluated the reconsideration request at length and determined that the staff had properly followed the DIDP in responding to the request from .GAY LLC and indicated that, again, the response to the request had identified numerous documents that had already been posted, identified certain documents that would be subject to nondisclosure for the conditions for nondisclosure under the DIDP, and then, finally, evaluated whether or not, withstanding the conditions for nondisclosure, if any of the documents should nevertheless be produced. And the ICANN organization decision was no. The BAMC evaluated that and came to the determination that the reconsideration request should be denied because there

was no basis for reconsideration in that the ICANN organization followed the policy in responding to the DIDP.

Again, here, the requestor was provided an opportunity to submit a rebuttal, which it did. And as the board has seen in the materials, the analysis of that rebuttal shows that nothing new was found in the rebuttal that would be subject to reconsideration. And accordingly, the recommendation stands that the BAMC's recommendation to deny the request be adopted by the board.

And, Chris, I'll leave it at that.
