R> We are writing to you about your recently submitted reconsideration request (Request 26-2). In Request 26-2, you state that you are “the registrant of one or more third-level .NAME domain names” and use “associated email services,” and that the approvals of RSEP 2026013 and RSEP 2026014 “may adversely affect [your] ability to continue holding these registrations” and services. To assist the ICANN Board Accountability Mechanisms Committee (BAMC) in determining whether Request 26-2 is sufficiently stated under ICANN Bylaws Article 4, Section 4.2(k), we kindly request that you provide additional information regarding the third-level .NAME domain names for which you indicate you are the registrant. The additional information that would be helpful includes a list of those domains, registration and expiration dates, as well as information regarding the “associated email services” that you use.

R> Please provide this additional information by 17 June 2026, which, as mentioned above, is needed to assist the BAMC in its initial evaluation of Request 26-2. Please note that the additional information you provide will be posted on the ICANN Reconsideration webpage regarding Request 26-2, as noted on the Reconsideration Request Form.
