## Proposed Service

Name of Proposed Service:

*Release and Allocation of One and Two Character Names*

Technical description of Proposed Service:

*RegistryPro initially reserved all one and two character second level names in the .PRO TLD as specified in Appendix K of our registry operator agreement. RegistryPro also reserved all three character names at the second level for use as profession specific second level domain labels (PSSLDs) in the expansion and development of .PRO.*

*RegistryPro now seeks approval for the release and allocation of these reserved names in a fair and equitable manner.*

*In April, 2008, during a special meeting of the ICANN Board of Directors, changes to .PRO's registry operator agreement were approved that included the internationalization of the TLD and the introduction of an End User Terms of Use Agreement (TOU).*

*Along with expansion of the geographic availability and distribution of .PRO names came approval to allow authorized registrars to offer "stand alone" resolving second level names, which did not require the use of two "supporting" third level names.*

*Our proposal also anticipated a move away from the PSSLD model for registry growth and development. This allowed the .PRO TLD to grow in a way more consistent with other, more successful TLDs, and has rendered the reservation of three character names obsolete.*

*Therefore, RegistryPro is also requesting the release of all three character names in the .PRO TLD that do not currently conflict with those specified in Appendix K of our registry operator agreement. These include:*

*RegistryPro anticipates a three phase implementation to be executed in the following order:*

- 1. An Request For Proposals (RFP) round to invite interested registrants to propose specific plans for use and promotion of these names;*
- 2. An auction round that offers domains not allocated during the RFP round; and*
- 3. A first-come, first-served (FCFS) release of any domains not allocated during the RFP or auction rounds.*

*These three components will include requirements related to eligibility and activation similar to those found in our current agreements, including our End User Terms of Use Agreement (TOU). A copy of the current TOU is available at <http://registry.pro/legal/user-terms.shtml>. All requirements related to eligibility and proper use must be met as a condition of registering these names.*

*RegistryPro proposes to amend our registry operator contract language and implement this phased allocation program to permit the introduction of one, two and character .PRO names in the DNS.*

## Consultation

*RegistryPro regularly receives emails from the public, our registrar partners, and prospective customers about the availability of one, two, and three character .PRO names.*

*In December 2008, after many inquiries from registrants, registrars, and the public, RegistryPro submitted a formal request to our Advisory Board for support and approval in the release of all one and two character .PRO names not currently reserved in Appendix K of our registry operator agreement. This proposal was discussed in email by members of our Advisory Board,*

*Upon approval, RegistryPro plans to release one and two character names as soon as is commercially reasonable.*

*The time line for implementation of this proposal depends on several factors.*

### *Phase One - RFP*

*RegistryPro anticipates using an RFP period for the initial phase of allocation. Several factors will contribute to the Phase One schedule, such as end-user response, number of RFPs related to the same name, and the registry's ability to dedicate organizational resources for this phase of the process.*

### *Phase Two - Auction*

*RegistryPro will use the RFP process, industry insight from auction specialists, and, when appropriate, feedback from other gTLD registries, to gauge appropriate time lines for this phase of allocation. We intend to respond to public demand for these names, while affording ourselves an opportunity to market and promote the .PRO TLD effectively.*

### *Phase Three - FCFS*

*The final step in the allocation process will be FCFS. Names that are not registered during the RFP and auction phases will be made available to all eligible registrants on a first come first served basis.*

*We anticipate the FCFS phase will begin 60 days after the finalization of the list of names to be auctioned.*

- 1. Use the name as their primary web address or for a specific marketing campaign*
- 2. Demonstrate a financial commitment to promoting their name*
- 3. Meet or exceed commitments made by any competing applicants*
- 4. Meet and agree to be bound by the terms and conditions in .PRO's TOU related to Professional and Proper use.*

## *\* Phase Two - Auction*

*Upon the completion of the RFP component, RegistryPro will conduct Phase Two of the allocation process. *Currently, one, two, and three character domains in the .PRO TLD are available at the third level using profession specific second level domains (PSSLDs).*

*Examples of currently registered one, two and three character names within PSSLDs include e.law.pro, fh.law.pro, and kgh.law.pro. The release of these reserved names at the second level is a natural and anticipated development in the TLD.*

*The implementation of the Registry Service would give a registrant like "Chris Professional" the opportunity to register c.pro, or cp.pro. So long as neither create confusion with any ISO country code and no copyright or trademark concerns are raised (or where trademark concerns are addressed in binding fashion), these name should be allocated as fairly as possible and "Chris Professional" should have an opportunity to apply for and use them. As is the case with all .PRO names, registrants will be required to submit proof of eligibility before the activation of any one, two or three character names.*

*With the expansion of the .PRO TLD in 2008, both in terms of geography and professional eligibility, it's important that .PRO not be restricted from answering the international demand for these names.*

## Amendment 5 to the .PRO Registry Agreement

ICANN and RegistryPro agree that the following modification is made to the May 2002 .pro Registry Agreement:

### Appendix K

[Old Text]

B. Additional Second-Level Reservations. In addition, the following names shall be reserved at the second-level:

All single-character labels.

All two-character labels shall be initially reserved. The reservation of a two-character label string shall be released to the extent that the Registry Operator reaches agreement with the government and country-code manager, or the ISO 3166 maintenance agency, whichever appropriate. The Registry Operator may also propose release of these reservations based on its implementation of measures to avoid confusion with the corresponding country codes.

All three-character labels shall be initially reserved by the Registry Operator. The reservation of a three-character label string shall be released to the Registry Operator in conjunction with the introduction of corresponding PS-SLDs and pursuant to the procedures outlined in Appendix L, Section 4.

Appendix C, Section 12

[New Text]

.PRO One, Two, and Three Character Phased Allocation Program (“Phased Allocation Program”). The domain names included within the scope of the Phased Allocation Program shall be limited to one, two, and three character .PRO domain names. RegistryPro reserves the right to not allocate all one, two and three character .PRO domain names.

Pursuant to the Phased Allocation Program, RegistryPro may elect to allocate the domain names via the following processes: 1) request for proposals based on evaluation criteria, 2) auction, or 3) first come, first served registration.

The domain names allocated via the Phased Allocation Program are an exception to the Maximum Service Fee described in Appendix G of the .PRO Registry Agreement.
