<b>Section I: General Overview and Next Steps</b>			
<p>The Generic Names Supporting Organization (GNSO) Standing Committee on Improvements Implementation (SCI) is recommending a modification of the GNSO Policy Development Process (PDP) Manual, which is an integral part of the GNSO Operating Procedures, to address the possible suspension of a PDP. Following the closing of the public comment forum, the SCI will review the comments received; revise its recommendations, if deemed appropriate; and submit these to the GNSO Council for its approval. If the GNSO Council approves the modifications they will be incorporated into a revised version of the PDP Manual and in a revision of the GNSO Council Operating Procedures, Annex 2.</p>

The RySG notes in its statement that it recognizes that there may be circumstances that warrant the temporary suspension of a PDP. Given that the PDP manual is an integral part of the GNSO Operating Procedures and that the PDP manual does not currently provide for the temporary suspension of a PDP, the RySG states that it believes that this is a necessary piece of work by the SCI. Moreover, the RySG supports the recommended changes that are proposed by the SCI. In addition, in its statement the RySG notes and supports the need for a supermajority vote of the GNSO Council in order to suspend or terminate a PDP and believe this to be an appropriate threshold for this course of action.
