Describe how the Proposed Service will be offered:

Sony Corporation intends to operate .SONY as a .BRAND Registry, in line with the requirements set forth in Specification 13. As such, all domains under .SONY will be registered to and controlled by Sony Corporation, its Affiliates, or its Trademark Licensees. Sony Corporation does not intend to sell .SONY domain names to the general public or to allow unaffiliated third parties to control the DNS records associated with domains in .SONY. The TLD will be used to feature e-commerce and other content particular to the Sony Corporation brand. We envision that country and territory names would be used as part of a navigation scheme to point users to relevant, geotargeted content. For instance, newzealand.SONY could be used to point users from New Zealand to local product and service offerings, or other locally-relevant content.\r\n
