As a background, XYZ is in the process of switching the backend for these TLDs from UNR to its normal backend, CentralNic. XYZ was just informed by CentralNic, that the following IDNs were causing issues with the RST for the technical transition: (1) Cyrillic Script, (2) Chinese Language, (3) Japanese Language, (4) German Language. (To be clear, no other IDNs are being removed -- just these three).

So, in order to move forward with the migration to CentralNic, we have no choice but to remove support for these IDNs. This will only impact fewer than 50 registrations in these TLDs.
