Jean-Jacques Subrenat: (07:25) @Alissa, I would insist on your sending the Proposal to the Administrator of the NTIA kind care of the Chair of the ICANN Board. I do NOT agree with the idea (proposed by Martin just now) of ICG "submitting" anything to the ICANN Board, for transmission etc. The Board has the OBLIGATION to transmit, and if it does not agree on any point, it can say so in its letter of transmission to NTIA. I wish my comment to be recorded in full in today's meeting minutes.

Manal Ismail: (07:26) Thanks James ..

Martin Boyle, ccNSO: (07:26) @Alissa: all for the better!

Jari Arkko: (07:27) board is doing this right

James Bladel: (07:27) Jean-Jaques - I think I recall a message from NTIA that they were expecting the proposal from ICANN Board, not ICG.

Jean-Jacques Subrenat: (07:28) @James, well that would not be in line with our own ToR...

Narelle Clark: (07:28) The USG has a contract with ICANN, not a third party or organisation of ICANN.

Manal Ismail: (07:28) Reading James, I now recall the same ..

Narelle Clark: (07:28) Hence ICANN's board must respond to the USG.

Jean-Jacques Subrenat: (07:28) @Narelle, ICG has no "contract" with anyone. ICG was formed as an independent body.

James Bladel: (07:29) +1 Narelle. That is my recollection as well.

Narelle Clark: (07:29) @JJ Exactly.

James Bladel: (07:29) Agree with Alissa.

Narelle Clark: (07:29) We have an implicit (and in parts explicit) delegation.

Narelle Clark: (07:30) ... a delegation to do some work and report.

Narelle Clark: (07:31) With the expectation that that work takes place in public and is reported to our own bodies to whom we represent.

Jean-Jacques Subrenat: (07:31) @Alissa, the wording could be "To the Administrator..., kind care of ..., Chairman of the ICANN Board". In short, it is to be written to the NTIA, c/o Board Chair.

Manal Ismail: (07:31) Just thinking out loud, can we have the proposal sent with 2 covers .. one addressed to the Board as our contact and another attached to the proposal addressed to NTIA?

Narelle Clark: (07:31) @Manal - no, we should just publish the report on the web site.

Xiaodong Lee: (07:31) I remember that icann board will forward ICG proposal directly without any amendment, if I am wrong pls correct me.

Martin Boyle, ccNSO: (07:32) @Daniel: we cannot be before the CCWG. But we can go immediately afterwards. Otherwise I agree with you fully

James Bladel: (07:32) Agreed, Martin.
