Jari Arkko: (01:20) (I hope we keep the numbering though, my personal record of submissions that I have looked at are based on the submission numbers)

Jennifer Chung: (01:20) @Russ - certainly I can add that

Jari Arkko: (01:20) thanks

Jennifer Chung: (01:20) @Jari - the submission IDs will not change

RussMundy-SSAC: (01:21) Thanks Jennifer

Jennifer Chung: (01:24) @Everyone - the document is un-synced for your review

Daniel Karrenberg: (01:26) surprise surprise

Paul Wilson: (01:31) The strong impression I get is that the board comments are substantial and will require another round of CCWG work, if it is to take ICANN into account.

Manal Ismail: (01:32) @Keith many thanks for the brief ..

Mary Uduma: (01:33) Thanks Keith for the briefing. Very helpful.

Paul Wilson: (01:35) This is my understanding as well. There will be an alternative proposal from ICANN.

Paul Wilson: (01:35) i only get this impression from what was said in the long (3-hour) public call. But I think it was very clear.

Manal Ismail: (01:36) I share the same impression Paul ..

Daniel Karrenberg: (01:37) the question for \*us\* us whether all this affects \*our\* , the icg's, work

Alissa Cooper: (01:39) @Daniel I don't think we know yet. But I am getting questions about this already. This is why it is good to get the update from Keith, and I expect us to spend a little time on this at the F2F once the CCWG comment period is closed.

Daniel Karrenberg: (01:39) don't get me wrong: the update is very very useful

Jari Arkko: (01:42) test (my adobeconnect acting up a bit)

Daniel Karrenberg: (01:42) @jari: reading you

Manal Ismail: (01:43) Although the Accountability discussions does not have direct impact on the final proposal in terms of substance yet it does have administrative impact in term of timelines and the overall submission process ..

Daniel Karrenberg: (01:44) i suggest when fielding questions about this our chairs, and all of us, should project that we are moving along with our work as scheduled

Patrik Fältström: (01:45) I am at last also on this call.

Daniel Karrenberg: (01:45) welcome to sth

Daniel Karrenberg: (01:45) @paf

Mary Uduma: (01:46) Welcome Patrik

Patrik Fältström: (01:46) thanks Daniel

Paul Wilson: (01:46) Strange - my mic not working.

Paul Wilson: (01:47) but, i was agreeing with independence of single-member and PTI models.

Paul Wilson: (01:47) also suggesting that we have to continue with our work.

Paul Wilson: (01:48) Also was going to ask if we have comments from ICANN on ICG proposal, and expressing a hope that if ICANN is concerned with PTI, they would have expressed it in the comment period.

Mary Uduma: (01:48) I think the ICG should continue with its work and schedules and timelines should also not be changed as we watch the process unfold

Manal Ismail: (01:48) May be we should add a question to our FAQ along those lines (and any other messages we would like to convey at this point in time) ..

Mary Uduma: (01:49) +1 Manna

Jari Arkko (new connection): (01:49) Thanks Keith for a very measured and rational explanation of the situation. And I agree with your assessment. I wanted to say that we should emphasise sticking to the process, keeping open mind about comments, keeping an open mind about there possibly being a need to adjust proposal based on public comments, and figuring out what issues there are before jumping to the adjustments.. But the community should be in charge, and CCWG, not necessarily any individual commenter. However, you should follow what the comments say.

Daniel Karrenberg: (01:49) +1 manal

Lynn St.Amour: (01:49) Good idea Manal

Keith Drazek: (01:51) Thanks Jari, I appreciate your comments.

Daniel Karrenberg: (01:51) i understand now.

Daniel Karrenberg: (01:52) but that is cwg's work an not ours, in my mind

Daniel Karrenberg: (01:52) understand, thanks!

Narelle Clark: (01:53) But as Alissa says, if the CWG deems the CCWG work as not meeting requirements, then their proposal to us is no longer complete.

Keith Drazek: (01:53) Correct Narelle

Daniel Karrenberg: (01:54) @narelle: clear but it is for cwg to determine that and give us a binary answer, e.g. yes/no

Narelle Clark: (01:54) or rather, cannot be considered complete.

Keith Drazek: (01:54) Also correct Daniel

Narelle Clark: (01:54) @daniel, agree it is the CWG to determine that.

Daniel Karrenberg: (01:56) where i am going is this: once we are done with producing the proposal we can go to sleep until cwg gives us the answer. if the answer is yes we wake up for a second and pass on the document. if the answer is no we need to make a new plan.

Daniel Karrenberg: (01:57) the point is that we should go to sleep when we are done with the document.

RussMundy-SSAC: (01:58) @Keith: Great update, thanks

Keith Drazek: (01:58) My pleasure. Kavouss and I will continue to report out of the CCWG discussions. Everyone should feel free to ping us on the list with any questions or comments.

Narelle Clark: (01:58) @Daniel it may be that the answer is neither yes, nor no, but not yet...
